## HOW TO USE THIS GUIDE

## Let's get started!

First, preview the entire guide. Learn what is discussed and where to find helpful information. Even though the focus of this guide is Geometry, you need to keep in mind your overall good reading habits.

Start reading with a pencil or a highlighter in your hand and sticky notes nearby.
Mark the important ideas, the things you might want to come back to, or the explanations you have questions about. On that last point, your teacher is your best resource.

You will find some key ideas and important tips to help you prepare for the test.
You can learn about the different types of items on the test.
When you come to the sample items, don't just read them, do them. Think about strategies you can use for finding the right answer. Then read the analysis of the item to check your work. The reasoning behind the correct answer is explained for you. It will help you see any faulty reasoning in the ones you may have missed.

For constructed-response questions, you will be directed to a rubric or scoring guide so you can see what is expected. The rubrics provide guidance on how students earn score points, including criteria for how to earn partial credit for these questions. Always do your best on these questions. Even if you do not know all of the information, you can get partial credit for your responses.

Use the activities in this guide to get hands-on understanding of the concepts presented in each unit.

With the Depth of Knowledge (DOK) information, you can gauge just how complex the item is. You will see that some items ask you to recall information and others ask you to infer or go beyond simple recall. The assessment will require all levels of thinking.

Plan your studying and schedule your time.
Proper preparation will help you do your best!


## OVERVIEW OF THE GEOMETRY EOC ASSESSMENT

## ITEM TYPES

The Geometry EOC assessment consists of selected-response, technology-enhanced, constructed-response, and extended constructed-response items.

A selected-response item, sometimes called a multiple-choice item, is a question, problem, or statement that is followed by four answer choices. These questions are worth one point.

A technology-enhanced item has a question, problem, or statement. You may be asked to select more than one right answer. Or, you may be asked to answer the first part of the question. Then, you will answer the second part of the question based on how you answered part one. These questions are worth 2 points. Partial credit may be awarded if you select some but not all of the correct answers or if you get one part of the question correct but not the other.

A constructed-response item asks a question and you provide a response that you construct on your own. These questions are worth two points. Partial credit may be awarded if part of the response is correct.

An extended constructed-response item is a specific type of constructed-response item that requires a longer, more detailed response. These items are worth four points. Partial credit may be awarded.

## Strategies for Answering Constructed-Response Items

2. Read the question or prompt carefully.
\& Think about what the question is asking you to do.
3. Add details, examples, or reasons that help support and explain your response.
\& Reread your response and be sure you have answered all parts of the question.
\& Be sure that the evidence you have provided supports your answer.
4. Your response will be scored based on the accuracy of your response and how well you have supported your answer with details and other evidence.

## DEPTH OF KNOWLEDGE DESCRIPTORS

Items found on the Georgia Milestones assessments, including the Geometry EOC assessment, are developed with a particular emphasis on the kinds of thinking required to answer questions. In current educational terms, this is referred to as Depth of Knowledge (DOK). DOK is measured on a scale of 1 to 4 and refers to the level of cognitive demand (different kinds of thinking) required to complete a task, or in this case, an assessment item. The following table shows the expectations of the four DOK levels in detail.

The DOK table lists the skills addressed in each level as well as common question cues. These question cues not only demonstrate how well you understand each skill but also relate to the expectations that are part of the state standards.

## Level 1—Recall of Information

Level 1 generally requires that you identify, list, or define. This level usually asks you to recall facts, terms, concepts, and trends and may ask you to identify specific information contained in documents, maps, charts, tables, graphs, or illustrations. Items that require you to "describe" and/or "explain" could be classified as Level 1 or Level 2. A Level 1 item requires that you just recall, recite, or reproduce information.

## Level 2—Basic Reasoning

Level 2 includes the engagement (use) of some mental processing beyond recalling or reproducing a response. A Level 2 "describe" and/or "explain" item would require that you go beyond a description or explanation of recalled information to describe and/or explain a result or "how" or "why."

## Level 3—Complex Reasoning

Level 3 requires reasoning, using evidence, and thinking on a higher and more abstract level than Level 1 and Level 2. You will go beyond explaining or describing "how and why" to justifying the "how and why" through application and evidence. Level 3 items often involve making connections across time and place to explain a concept or a "big idea."

## Level 4-Extended Reasoning

Level 4 requires the complex reasoning of Level 3 with the addition of planning, investigating, applying significant conceptual understanding, and/or developing that will most likely require an extended period of time. You may be required to connect and relate ideas and concepts within the content area or among content areas in order to be at this highest level. The Level 4 items would be a show of evidence, through a task, a product, or an extended response, that the cognitive demands have been met.

## Example Item 1

## Selected-Response

DOK Level 1: This is a DOK Level 1 item because it requires the student to demonstrate an understanding of dilations and determining the scale factor.

Geometry Content Domain: Congruence and Similarity
Standard: MGSE9-12.G.SRT.1b. The dilation of a line segment is longer or shorter according to the ratio given by the scale factor.

The smaller triangle is transformed to create the larger triangle. Which of these is the scale factor of the dilation centered at the point $(0,0)$ ?

A. 4
B. 2
C. 1
D. $\frac{1}{2}$

## Correct Answer: B

Explanation of Correct Answer: The correct answer is choice (B). Since the length of each segment has doubled, the scale factor is 2 , choice ( $B$ ). $\overline{A B}$ increases to a length of 4 , but the scale factor is found by determining what the length is multiplied by, so choice (A) is incorrect. Choice (C) is incorrect since a scale factor of 1 does not change the size of the pre-image. Choice (D) is incorrect because it represents the scale factor when the pre-image and image are reversed.

## Example Item 2

## Constructed-Response

DOK Level 2: This is a DOK Level 2 item because it requires the student to apply a formula.

## Geometry Content Domain: Geometry

Standard: MGSE9-12.G.GMD.3. Use volume formulas for cylinders, pyramids, cones, and spheres to solve problems.

A sandcastle mold is in the shape of a cylinder with a diameter of 6 inches and a height of 8 inches.

To the nearest cubic inch, how much sand will fit in the sandcastle mold? Explain how you determined your answer. In your explanation, use the word pi instead of the symbol $\pi$. Write your answer on the lines provided.

Geometry Content Domain: Equations and Measurement
Standard: MGSE9-12.G.GPE.4. Use coordinates to prove simple geometric theorems algebraically. For example, prove or disprove that a figure defined by four given points in the coordinate plane is a rectangle; prove or disprove that the point $(1, \sqrt{3})$ lies on the circle centered at the origin and containing the point $(0,2)$.
(Focus on quadrilaterals, right triangles, and circles.)

1. $A B C D$ is a parallelogram. Prove that the diagonals of $A B C D$ bisect each other and justify each step.

## DESCRIPTION OF TEST FORMAT AND ORGANIZATION

The Georgia Milestones Geometry EOC assessment consists of a total of 73 items. You will be asked to respond to selected-response (multiple-choice), technology-enhanced, constructed-response, and extended constructed-response items.

The test will be given in two sections.

- You may have up to 85 minutes per section to complete Sections 1 and 2.
- The total estimated testing time for the Geometry EOC assessment ranges from approximately 120 to 170 minutes. Total testing time describes the amount of time you have to complete the assessment. It does not take into account the time required for the test examiner to complete pre-administration and post-administration activities (such as reading the standardized directions to students).
- Sections 1 and 2 may be administered on the same day or across two consecutive days, based on the district's testing protocols for the EOC measures (in keeping with state guidance).
- During the Geometry EOC assessment, a formula sheet will be available for you to use. Another feature of the Geometry assessment is that you may use a graphing calculator in calculator-approved sections.


## Effect on Course Grade

It is important that you take this course and the EOC assessment very seriously.

- For students in Grade 10 or above beginning with the 2011-2012 school year, the final grade in each course is calculated by weighing the course grade $85 \%$ and the EOC score 15\%.
- For students in Grade 9 beginning with the 2011-2012 school year and later, the final grade in each course is calculated by weighing the course grade $80 \%$ and the EOC score $20 \%$.
- A student must have a final grade of at least $70 \%$ to pass the course and to earn credit toward graduation.

## ACTIVE PARTICIPATION

The most important element in your preparation is you. You and your actions are the key ingredient. Your active studying helps you stay alert and be more productive. In short, you need to interact with the course content. Here's how you do it.
2. Carefully read the information and then DO something with it. Mark the important material with a highlighter, circle it with a pen, write notes on it, or summarize the information in your own words.
2. Ask questions. As you study, questions often come into your mind. Write them down and actively seek the answers.
\& Create sample test questions and answer them.
2. Find a friend who is also planning to take the test and quiz each other.

## TEST-TAKING STRATEGIES

Part of preparing for a test is having a set of strategies you can draw from. Include these strategies in your plan:

* Read and understand the directions completely. If you are not sure, ask a teacher.
* Read each question and all of the answer choices carefully.
* If you use scratch paper, make sure you copy your work to your test accurately.
* Underline important parts of each task. Make sure that your answer goes on the answer sheet.
* Be aware of time. If a question is taking too much time, come back to it later.
* Answer all questions. Check your answers for accuracy. For constructed-response questions, do as much as you can. Remember, partially correct responses will earn a partial score.
* Stay calm and do the best you can.

- Look at the sample answers for the constructed-response items to familiarize yourself with the elements of the exemplary responses. The rubrics will explain what is expected of you, point by point.

- There are additional items to practice your skills available online. Ask your teacher about online practice sites that are available for your use.

The content of the assessment is organized into four groupings, or domains, of standards for the purpose of providing feedback on student performance.
2. A content domain is a reporting category that broadly describes and defines the content of the course, as measured by the EOC assessment.
2n the actual test the standards for Geometry are grouped into four domains that follow your classwork: Congruence and Similarity; Circles; Equations and Measurement; and Statistics and Probability.
2s Each domain was created by organizing standards that share similar content characteristics.
2 The content standards describe the level of understanding each student is expected to achieve. They include the knowledge, concepts, and skills assessed on the EOC assessment, and they are used to plan instruction throughout the course.

## SNAPSHOT OF THE COURSE

This section of the guide is organized into six units that review the material taught within the four domains of the Geometry course. The material is presented by concept rather than by category or standard. In each unit you will find sample items similar to what you will see on the EOC assessment. The next section of the guide contains additional items to practice your skills followed by a table that shows for each item the standard assessed, the DOK level, the correct answer (key), and a rationale/ explanation about the key and distractors.

## UNIT 1: TRANSFORMATIONS IN THE COORDINATE PLANE

In this unit, students review the definitions of three types of transformations that preserve distance and angle: rotations, reflections, and translations. They investigate how these transformations are applied in the coordinate plane as functions, mapping pre-image points (inputs) to image points (outputs). Using their knowledge of basic geometric figures and special polygons, they apply these transformations to obtain images of given figures. They also specify transformations that can be applied to obtain a given image from a given pre-image, including cases in which the image and pre-image are the same figure.

## Experiment with Transformations in the Plane

MGSE9-12.G.CO.1 Know precise definitions of angle, circle, perpendicular line, parallel line, and line segment, based on the undefined notions of point, line, distance along a line, and distance around a circular arc.

MGSE9-12.G.CO. 2 Represent transformations in the plane using, e.g., transparencies and geometry software; describe transformations as functions that take points in the plane as inputs and give other points as outputs. Compare transformations that preserve distance and angle to those that do not (e.g., translation versus horizontal stretch).

MGSE9-12.G.C0.3 Given a rectangle, parallelogram, trapezoid, or regular polygon, describe the rotations and reflections that carry it onto itself.

MGSE9-12.G.CO. 4 Develop definitions of rotations, reflections, and translations in terms of angles, circles, perpendicular lines, parallel lines, and line segments.

MGSE9-12.G.C0.5 Given a geometric figure and a rotation, reflection, or translation, draw the transformed figure using, e.g., graph paper, tracing paper, or geometry software. Specify a sequence of transformations that will carry a given figure onto another.

## KEY IDEAS

1. A line segment is part of a line; it consists of two points and all points between them. An angle is formed by two rays with a common endpoint. A circle is the set of all points in a plane that are equidistant from a given point, called the center; the fixed distance is the radius. Parallel lines are lines in the same plane that do not intersect. Perpendicular lines are two lines that intersect to form right angles.


Line segment $A B$


Angle $P Q R$


Circle $P$ with radius $r$


Parallel lines $a$ and $b$


Perpendicular lines $m$ and $n$
2. A transformation is an operation that maps, or moves, a pre-image onto an image. In each transformation defined below, it is assumed that all points and figures are in one plane. In each case, $\triangle A B C$ is the pre-image and $\triangle A^{\prime} B^{\prime} C^{\prime}$ is the image.


A translation maps every two points $P$ and $Q$ to points $P^{\prime}$ and $Q^{\prime}$ so that the following properties are true:

- $P P^{\prime}=Q Q^{\prime}$
- $\overline{P P^{\prime}} \| \overline{Q Q^{\prime}}$


A reflection across a line $m$ maps every point $R$ to $R^{\prime}$ so that the following properties are true:

- If $R$ is not on $m$, then $m$ is the perpendicular bisector of $\overline{R R^{\prime}}$.
- If $R$ is on $m$, then $R$ and $R^{\prime}$ are the same point.


A rotation of $x^{\circ}$ about a point $Q$ maps every point $S$ to $S^{\prime}$ so that the following properties are true:

- $S Q=S^{\prime} Q$ and $m \angle S Q S^{\prime}=x^{\circ}$.
- Pre-image point $Q$ and image point $Q^{\prime}$ are the same.

Note: $\overline{Q S}$ and $\overline{Q S^{\prime}}$ are radii of a circle with center $Q$.
3. A transformation in a coordinate plane can be described as a function that maps pre-image points (inputs) to image points (outputs). Translations, reflections, and rotations all preserve distance and angle measure because, for each of those transformations, the pre-image and image are congruent. But some types of transformations do not preserve distance and angle measure because the pre-image and image are not congruent.

$T_{1}:(x, y) \rightarrow(x+2, y)$
$T_{1}$ translates $\triangle A B C$ to the right 2 units.
$T_{1}$ preserves distance and angle measure because $\triangle A B C \cong \triangle A^{\prime} B^{\prime} C^{\prime}$.

$T_{2}:(x, y) \rightarrow(2 x, y)$ $T_{2}$ stretches $\triangle A B C$ horizontally by the factor 2.
$T_{2}$ preserves neither distance nor angle measure.
4. If vertices are not named, then there might be more than one transformation that will accomplish a specified mapping. If vertices are named, then they must be mapped in a way that corresponds to the order in which they are named.


Figure 1 can be mapped to Figure 2 by either of these transformations:

- a reflection across the $y$-axis (the upper-left vertex in Figure 1 is mapped to the upper-right vertex in Figure 2) or
- a translation 4 units to the right (the upper-left vertex in Figure 1 is mapped to the upper-left vertex in Figure 2).

$A B C D$ can be mapped to $E F G H$ by a reflection across the $y$-axis, but not by a translation.

The mapping of $A B C D \rightarrow E F G H$ requires these vertex mappings: $A \rightarrow E, B \rightarrow F, C \rightarrow G$, and $D \rightarrow H$.

## Solution:



Translate $A B C D$ down 5 units to obtain $A^{\prime} B^{\prime} C^{\prime} D^{\prime}$. Then rotate $A^{\prime} B^{\prime} C^{\prime} D^{\prime}$ clockwise $90^{\circ}$ about point $B^{\prime}$ to obtain PQRS.


Reflect $A B C D$ across the line $x=2$ to obtain $A^{\prime} B^{\prime} C^{\prime} D^{\prime}$. Then rotate $A^{\prime} B^{\prime} C^{\prime} D^{\prime}$ $180^{\circ}$ about point $A^{\prime}$ to obtain $P Q R S$.

Note that $A^{\prime}$ and $P$ are the same point.

Note that there are other sequences of transformations that will also work for each case.

## Important Tip

2. A $180^{\circ}$ rotation clockwise is equivalent to a $180^{\circ}$ rotation counterclockwise.

## Solution:

a.


There is only one transformation: Reflect the figure across the line $y=-1$.


There are three transformations:

- reflect across the line $y=1$, or
- reflect across the line $x=-2$, or
- rotate $180^{\circ}$ about the point $(-2,1)$.

4. Describe every transformation that maps this figure to itself: a regular hexagon ( 6 sides) that is centered about the origin and that has a vertex at ( 4,0 ).

## Solution:

The angle formed by any two consecutive vertices and the center of the hexagon measures $60^{\circ}$ because $\frac{360^{\circ}}{6}=60^{\circ}$. So a rotation about the origin, clockwise or counterclockwise, of $60^{\circ}, 120^{\circ}$, or any other multiple of $60^{\circ}$ maps the hexagon to itself.


If a reflection across a line maps a figure to itself, then that line is called a line of symmetry.

A regular hexagon has 6 lines of symmetry: 3 lines through opposite vertices and 3 lines through midpoints of opposite sides.

A reflection across any of the 6 lines of symmetry maps the hexagon to itself.

## UNIT 2: SIMILARITY, CONGRUENCE, AND PROOFS

This unit introduces the concepts of similarity and congruence. The definition of similarity is explored through dilation transformations. The concept of scale factor with respect to dilations allows figures to be enlarged or reduced. Rigid motions lead to the definition of congruence. Once congruence is established, various congruence criteria (e.g., ASA, SSS, SAS) can be explored. Once similarity is established, various similarity criteria (e.g., AA) can be explored. These criteria, along with other postulates and definitions, provide a framework to be able to prove various geometric proofs. In this unit, various geometric figures are constructed. These topics allow students a deeper understanding of formal reasoning, which will be beneficial throughout the remainder of Analytic Geometry. Students are asked to prove theorems about parallelograms. Theorems include opposite sides are congruent, opposite angles are congruent, the diagonals of a parallelogram bisect each other, and, conversely, rectangles are parallelograms with congruent diagonals. The method for proving is not specified, so it could be done by using knowledge of congruency and establishing a formalized proof, it could be proven by constructions, or it could be proved algebraically by using the coordinate plane.

## Understand Similarity in Terms of Similarity Transformations

MGSE9-12.G.SRT. 1 Verify experimentally the properties of dilations given by a center and a scale factor.
a. The dilation of a line not passing through the center of the dilation results in a parallel line and leaves a line passing through the center unchanged.
b. The dilation of a line segment is longer or shorter according to the ratio given by the scale factor.

MGSE9-12.G.SRT. 2 Given two figures, use the definition of similarity in terms of similarity transformations to decide if they are similar; explain, using similarity transformations, the meaning of similarity for triangles as the equality of all corresponding pairs of angles and the proportionality of all corresponding pairs of sides.

MGSE9-12.G.SRT. 3 Use the properties of similarity transformations to establish the AA criterion for two triangles to be similar.

## KEY IDEAS

1. A dilation is a transformation that changes the size of a figure, but not the shape, based on a ratio given by a scale factor with respect to a fixed point called the center. When the scale factor is greater than 1 , the figure is made larger. When the scale factor is between 0 and 1 , the figure is made smaller. When the scale factor is 1 , the figure does not change. When the center of dilation is the origin, you can multiply each coordinate of the original figure, or pre-image, by the scale factor to find the coordinates of the dilated figure, or image.

## Example:

The diagram below shows $\triangle A B C$ dilated about the origin with a scale factor of 2 to create $\triangle A^{\prime} B^{\prime} C^{\prime}$.

2. When the center of dilation is not the origin, you can use a rule that is derived from shifting the center of dilation, multiplying the shifted coordinates by the scale factor, and then shifting the center of dilation back to its original location. For a point $(x, y)$ and a center of dilation ( $x_{c}, y_{c}$ ), the rule for finding the coordinates of the dilated point with a scale factor of $k$ is $\left(x_{c}+k\left(x-x_{c}\right), k\left(y-y_{c}\right)+y_{c}\right)$.


When a figure is transformed under a dilation, the corresponding angles of the pre-image and the image have equal measures.

For $\triangle A B C$ and $\triangle A^{\prime} B^{\prime} C^{\prime}$ on the next page, $\angle A \cong \angle A^{\prime}, \angle B \cong \angle B^{\prime}$, and $\angle C \cong \angle C^{\prime}$.
When a figure is transformed under a dilation, the corresponding sides of the pre-image and the image are proportional.
For $\triangle A B C$ and $\triangle A^{\prime} B^{\prime} C^{\prime}$ on the next page, $\frac{A B}{A^{\prime} B^{\prime}}=\frac{B C}{B^{\prime} C^{\prime}}=\frac{A C}{A^{\prime} C^{\prime}}$.
So, when a figure is under a dilation transformation, the pre-image and the image are similar.

For $\triangle A B C$ and $\triangle A^{\prime} B^{\prime} C^{\prime}$ below, $\triangle A B C \sim \triangle A^{\prime} B^{\prime} C^{\prime}$.

3. When a figure is dilated, a segment of the pre-image that does not pass through the center of dilation is parallel to its image. In the figure below, $\overline{A C} \| \overline{A^{\prime} C^{\prime}}$ since neither segment passes through the center of dilation. The same is true about $\overline{A B}$ and $\overline{A^{\prime} B^{\prime}}$ as well as $\overline{B C}$ and $\overline{B^{\prime} C^{\prime}}$.


When the segment of a figure does pass through the center of dilation, the segment of the pre-image and image are on the same line. In the figure below, the center of dilation is on $\overline{A C}$, so $\overline{A C}$ and $\overline{A^{\prime} C^{\prime}}$ are on the same line.


## REVIEW EXAMPLES

1. Draw a triangle with vertices at $A(0,1), B(-3,3)$, and $C(1,3)$. Dilate the triangle using a scale factor of 1.5 and a center of $(0,0)$. Sketch and name the dilated triangle $A^{\prime} B^{\prime} C^{\prime}$.

## Solution:

Plot points $A(0,1), B(-3,3)$, and $C(1,3)$. Draw $\overline{A B}, \overline{A C}$, and $\overline{B C}$.


The center of dilation is the origin, so to find the coordinates of the image, multiply the coordinates of the pre-image by the scale factor 1.5.

Point $A^{\prime}:(1.5 \cdot 0,1.5 \cdot 1)=(0,1.5)$
Point $B^{\prime}:(1.5 \cdot(-3), 1.5 \cdot 3)=(-4.5,4.5)$
Point $C^{\prime}:(1.5 \cdot 1,1.5 \cdot 3)=(1.5,4.5)$
Plot points $A^{\prime}(0,1.5), B^{\prime}(-4.5,4.5)$, and $C^{\prime}(1.5,4.5)$. Draw $\overline{A^{\prime} B^{\prime}}, \overline{A^{\prime} C^{\prime}}$, and $\overline{B^{\prime} C^{\prime}}$.


Note: Since no part of the pre-image passes through the center of dilation, $\overline{B C} \| \overline{B^{\prime} C^{\prime}}$, $\overline{A B} \| \overline{A^{\prime} B^{\prime}}$, and $\overline{A C} \| \overline{A^{\prime} C^{\prime}}$.
2. Line segment $C D$ is 5 inches long. If line segment $C D$ is dilated to form line segment $C^{\prime} D^{\prime}$ with a scale factor of 0.6 , what is the length of line segment $C^{\prime} D^{\prime}$ ?

## Solution:

The ratio of the length of the image and the pre-image is equal to the scale factor.

$$
\frac{C^{\prime} D^{\prime}}{C D}=0.6
$$

Substitute 5 for $C D$.

$$
\frac{C^{\prime} D^{\prime}}{5}=0.6
$$

Solve for $C^{\prime} D^{\prime}$.
$C^{\prime} D^{\prime}=0.6 \cdot 5$
$C^{\prime} D^{\prime}=3$
The length of line segment $C^{\prime} D^{\prime}$ is 3 inches.
3. Figure $A^{\prime} B^{\prime} C^{\prime} D^{\prime}$ is a dilation of figure $A B C D$.

a. Determine the center of dilation.
b. Determine the scale factor of the dilation.

## Solution:

a. To find the center of dilation, draw lines connecting each corresponding vertex from the pre-image to the image. The lines meet at the center of dilation.


The center of dilation is $(4,2)$.
b. Find the ratios of the lengths of the corresponding sides.
$\frac{A^{\prime} B^{\prime}}{A B}=\frac{6}{12}=\frac{1}{2}$
$\frac{B^{\prime} C^{\prime}}{B C}=\frac{3}{6}=\frac{1}{2}$
$\frac{C^{\prime} D^{\prime}}{C D}=\frac{6}{12}=\frac{1}{2}$
$\frac{A^{\prime} D^{\prime}}{A D}=\frac{3}{6}=\frac{1}{2}$
The ratio for each pair of corresponding sides is $\frac{1}{2}$, so the scale factor is $\frac{1}{2}$.
c. Each side of the image is parallel to the corresponding side of its pre-image and is $\frac{1}{2}$ the length.
Note: Lines connecting corresponding points pass through the center of dilation.

## Prove Theorems Involving Similarity

MGSE9-12.G.SRT. 4 Prove theorems about triangles. Theorems include: a line parallel to one side of a triangle divides the other two proportionally, (and its converse); the Pythagorean Theorem using triangle similarity.

MGSE9-12.G.SRT. 5 Use congruence and similarity criteria for triangles to solve problems and to prove relationships in geometric figures.

## KEY IDEAS

1. When proving that two triangles are similar, it is sufficient to show that two pairs of corresponding angles of the triangles are congruent. This is called Angle-Angle (AA) Similarity.

## Example:

The triangles below are similar by AA Similarity because each triangle has a $60^{\circ}$ angle and a $90^{\circ}$ angle. The similarity statement is written as $\triangle A B C \sim \triangle D E F$, and the order in which the vertices are written indicates which angles/sides correspond to each other.

2. When a triangle is dilated, the pre-image and the image are similar triangles. There are three cases of triangles being dilated:

- The image is congruent to the pre-image (scale factor of 1 ).
- The image is smaller than the pre-image (scale factor between 0 and 1 ).
- The image is larger than the pre-image (scale factor greater than 1 ).

3. When two triangles are similar, all corresponding pairs of angles are congruent.
4. When two triangles are similar, all corresponding pairs of sides are proportional.
5. When two triangles are congruent, the triangles are also similar.
6. A two-column proof is a series of statements and reasons often displayed in a chart that works from given information to the statement that needs to be proven. Reasons can be given information, can be based on definitions, or can be based on postulates or theorems.
7. A paragraph proof also uses a series of statements and reasons that work from given information to the statement that needs to be proven, but the information is presented as running text in paragraph form.

## Understand Congruence in Terms of Rigid Motions

1. A rigid motion is a transformation of points in space consisting of a sequence of one or more translations, reflections, and/or rotations (in any order). This transformation leaves the size and shape of the original figure unchanged.
2. Two plane or solid figures are congruent if one can be obtained from the other by rigid motion (a sequence of rotations, reflections, and translations). Congruent figures have the same corresponding side lengths and the same corresponding angle measures as each other.
3. Two triangles are congruent if and only if their corresponding sides and corresponding angles are congruent. This is sometimes referred to as CPCTC, which means Corresponding Parts of Congruent Triangles are Congruent.
4. When given two congruent triangles, you can use a series of translations, reflections, and rotations to show the triangles are congruent.
5. You can use ASA (Angle-Side-Angle) to show two triangles are congruent. If two angles and the included side of a triangle are congruent to two angles and the included side of another triangle, then the triangles are congruent.
$\triangle A B C \cong \triangle D E F$ by ASA.

6. You can use SSS (Side-Side-Side) to show two triangles are congruent. If three sides of a triangle are congruent to three sides of another triangle, then the triangles are congruent.
$\triangle G I H \cong \triangle J L K$ by SSS.

7. You can use SAS (Side-Angle-Side) to show two triangles are congruent. If two sides and the included angle of a triangle are congruent to two sides and the included angle of another triangle, then the triangles are congruent.
$\triangle M P N \cong \triangle Q S R$ by $S A S$.

8. You can use AAS (Angle-Angle-Side) to show two triangles are congruent. If two angles and a non-included side of a triangle are congruent to two angles and the corresponding non-included side of another triangle, then the triangles are congruent.
$\triangle V T U \cong \triangle Y W X$ by AAS.


## Important Tips

\&. If two sides and a non-included angle of one triangle are congruent to two sides and a non-included angle of a second triangle, the triangles are not necessarily congruent. Therefore, there is no way to show triangle congruency by Side-Side-Angle (SSA).
2. If two triangles have all three angles congruent to each other, the triangles are similar, but not necessarily congruent. Thus, you can show similarity by Angle-AngleAngle (AAA), but you cannot show congruence by AAA.

## REVIEW EXAMPLES

1. Is $\triangle A B C$ congruent to $\triangle M N P$ ? Explain.

(scale unit = 2)

## Solution:

$\overline{A C}$ corresponds to $\overline{M P}$. Both segments are 6 units long. $\overline{B C}$ corresponds to $\overline{N P}$. Both segments are 9 units long. Angle $C$ (the included angle of $\overline{A C}$ and $\overline{B C}$ ) corresponds to angle $P$ (the included angle of $\overline{M P}$ and $\overline{N P}$ ). Both angles measure $90^{\circ}$. Because two sides and an included angle are congruent, the triangles are congruent by SAS.

Or, $\triangle A B C$ is a reflection of $\triangle M N P$ over the $y$-axis. This means that all of the corresponding sides and corresponding angles are congruent, so the triangles are congruent. (Reflections preserve angle measurement and lengths; therefore, corresponding angles and sides are congruent.)
2. Rectangle $W X Y Z$ has coordinates $W(1,2), X(3,2), Y(3,-3)$, and $Z(1,-3)$.
a. Graph the image of rectangle $W X Y Z$ after a rotation of $90^{\circ}$ clockwise about the origin. Label the image $W^{\prime} X^{\prime} Y^{\prime} Z^{\prime}$.
b. Translate rectangle $W^{\prime} X^{\prime} Y^{\prime} Z^{\prime} 2$ units left and 3 units up.
c. Is rectangle $W X Y Z$ congruent to rectangle $W^{\prime \prime} X^{\prime \prime} Y^{\prime \prime} Z^{\prime \prime}$ ? Explain.

## Solution:

a. For a $90^{\circ}$ clockwise rotation about the origin, use the rule $(x, y) \rightarrow(y,-x)$.

& W(1,2) \rightarrow W^{\prime}(2,-1) \\
& X(3,2) \rightarrow X^{\prime}(2,-3) \\
& Y(3,-3) \rightarrow Y^{\prime}(-3,-3) \\
& Z(1,-3) \rightarrow Z^{\prime}(-3,-1)
\end{aligned}
$$


b. To translate rectangle $W^{\prime} X^{\prime} Y^{\prime} Z^{\prime} 2$ units left and 3 units up, use the rule $(x, y) \rightarrow(x-2, y+3)$.

$$
\begin{aligned}
& W^{\prime}(2,-1) \rightarrow W^{\prime \prime}(0,2) \\
& X^{\prime}(2,-3) \rightarrow X^{\prime \prime}(0,0) \\
& Y^{\prime}(-3,-3) \rightarrow Y^{\prime \prime}(-5,0) \\
& Z^{\prime}(-3,-1) \rightarrow Z^{\prime \prime}(-5,2)
\end{aligned}
$$


c. Rectangle $W^{\prime \prime} X^{\prime \prime} Y^{\prime \prime} Z^{\prime \prime}$ is the result of a rotation and a translation of rectangle $W X Y Z$. These are both rigid transformations, so the shape and the size of the original figure are unchanged. All of the corresponding parts of $W X Y Z$ and $W^{\prime \prime} X^{\prime \prime} Y^{\prime \prime} Z^{\prime \prime}$ are congruent, so $W X Y Z$ and $W^{\prime \prime} X^{\prime \prime} Y^{\prime \prime} Z^{\prime \prime}$ are congruent.

1. Parallelogram $F G H J$ was translated 3 units down to form parallelogram $F^{\prime} G^{\prime} H^{\prime} J^{\prime}$. ## Prove Geometric Theorems

MGSE9-12.G.CO.9 Prove theorems about lines and angles. Theorems include: vertical angles are congruent; when a transversal crosses parallel lines, alternate interior angles are congruent and corresponding angles are congruent; points on a perpendicular bisector of a line segment are exactly those equidistant from the segment's endpoints.

MGSE9-12.G.CO.10 Prove theorems about triangles. Theorems include: measures of interior angles of a triangle sum to 180 degrees; base angles of isosceles triangles are congruent; the segment joining midpoints of two sides of a triangle is parallel to the third side and half the length; the medians of a triangle meet at a point.

MGSE9-12.G.CO. 11 Prove theorems about parallelograms. Theorems include: opposite sides are congruent, opposite angles are congruent, the diagonals of a parallelogram bisect each other, and conversely, rectangles are parallelograms with congruent diagonals.

## KEY IDEAS

1. A two-column proof is a series of statements and reasons often displayed in a chart that works from given information to the statement that needs to be proven. Reasons can be given information, can be based on definitions, or can be based on postulates or theorems.
2. A paragraph proof also uses a series of statements and reasons that work from given information to the statement that needs to be proven, but the information is presented as running text in paragraph form.
3. It is important to plan a geometric proof logically. Think through what needs to be proven and decide how to get to that statement from the given information. Often a diagram or a flow chart will help to organize your thoughts.
4. An auxiliary line is a line drawn in a diagram that makes other figures, such as congruent triangles or angles formed by a transversal. Many times, an auxiliary line is needed to help complete a proof.
5. Once a theorem in geometry has been proven, that theorem can be used as a reason in future proofs.
6. Some important key ideas about lines and angles include the following:

- Vertical Angle Theorem: Vertical angles are congruent.
- Alternate Interior Angles Theorem: If two parallel lines are cut by a transversal, then alternate interior angles formed by the transversal are congruent.
- Corresponding Angles Postulate: If two parallel lines are cut by a transversal, then corresponding angles formed by the transversal are congruent.
- Points on a perpendicular bisector of a line segment are equidistant from both of the segment's endpoints.

7. Some important key ideas about triangles include the following:

- Triangle Angle-Sum Theorem: The sum of the measures of the angles of a triangle is $180^{\circ}$.
- Isosceles Triangle Theorem: If two sides of a triangle are congruent, then the angles opposite those sides are also congruent.
- Triangle Midsegment Theorem: If a segment joins the midpoints of two sides of a triangle, then the segment is parallel to the third side and half its length.
- Points of Concurrency: incenter, centroid, orthocenter, and circumcenter

8. Some important key ideas about parallelograms include the following:

- Opposite sides are congruent and opposite angles are congruent.
- The diagonals of a parallelogram bisect each other.
- If the diagonals of a quadrilateral bisect each other, then the quadrilateral is a parallelogram.
- A rectangle is a parallelogram with congruent diagonals.

2. In this diagram, $\overline{X Y}$ is parallel to $\overline{A C}$, and point $B$ lies on $\overrightarrow{X Y}$.


Write a paragraph to prove that the sum of the angles in a triangle is $180^{\circ}$.

## Solution:

$\overline{A C}$ and $\overline{X Y}$ are parallel, so $\overline{A B}$ is a transversal. The alternate interior angles formed by the transversal are congruent. So, $m \angle A=m \angle A B X$. Similarly, $\overline{B C}$ is a transversal, so $m \angle C=m \angle C B Y$. The sum of the angle measures that make a straight line is $180^{\circ}$.

So, $m \angle A B X+m \angle A B C+m \angle C B Y=180^{\circ}$. Now, substitute $m \angle A$ for $m \angle A B X$ and $m \angle C$ for $m \angle C B Y$ to get $m \angle A+m \angle A B C+m \angle C=180^{\circ}$.
3. In this diagram, $A B C D$ is a parallelogram and $\overline{B D}$ is a diagonal.


Write a two-column proof to show that $\overline{A B}$ and $\overline{C D}$ are congruent.

## Solution:

Construct a proof using properties of the parallelogram and its diagonal.

## Make Geometric Constructions

Copying a segment; copying an angle; bisecting a segment; bisecting an angle; constructing perpendicular lines, including the perpendicular bisector of a line segment; and constructing a line parallel to a given line through a point not on the line.

MGSE9-12.G.CO.13 Construct an equilateral triangle, a square, and a regular hexagon, each inscribed in a circle.

## KEY IDEAS

1. To copy a segment, follow the steps given:

Given: $\overline{A B}$


Construct: $\overline{P Q}$ congruent to $\overline{A B}$
Procedure:

1. Use a straightedge to draw a line, $I$.
2. Choose a point on line $I$ and label it point $P$.
3. Place the compass point on point $A$.
4. Adjust the compass width to the length of $\overline{A B}$.
5. Without changing the compass, place the compass point on point $P$ and draw an arc intersecting line $I$. Label the point of intersection as point $Q$.
6. $\overline{P Q} \cong \overline{A B}$.

7. To copy an angle, follow the steps given:

Given: $\angle A B C$


Construct: $\angle Q R Y$ congruent to $\angle A B C$

Procedure:

1. Draw a point $R$ that will be the vertex of the new angle.
2. From point $R$, use a straightedge to draw $\overrightarrow{R Y}$, which will become one side of the new angle.
3. Place the compass point on vertex $B$ and draw an arc through point $A$.

Construct: The perpendicular bisector of $\overline{A B}$

1. Adjust the compass to a width greater than half the length of $\overline{A B}$.
2. Place the compass on point $A$ and draw an arc passing above $\overline{A B}$ and an arc passing below $\overline{A B}$.
3. Without changing the compass width, place the compass on point $B$ and draw an arc passing above and an arc passing below $\overline{A B}$.
4. Use a straightedge to draw a line through the points of intersection of these arcs.
5. The segment is the perpendicular bisector of $\overline{A B}$.


Note: To bisect $\overline{A B}$, follow the same steps listed above to construct the perpendicular bisector. The point where the perpendicular bisector intersects $\overline{A B}$ is the midpoint of $\overline{A B}$.
5. To construct a line perpendicular to a given line through a point not on the line, follow the steps given:

Given: Line $I$ and point $P$ that is not on line $I \longrightarrow \ell$
Construct: The line perpendicular to line / through point $P$
Procedure:

1. Place the compass point on point $P$.
2. Open the compass to a distance that is wide enough to draw two arcs across line $I$, one on each side of point $P$. Label these points $Q$ and $R$.
3. From points $Q$ and $R$, draw arcs on the opposite side of line $/$ from point $P$ so that the arcs intersect. Label the intersection point $S$.
4. Using a straightedge, draw $\overleftrightarrow{P S}$.
5. $\overline{P S} \perp \overline{Q R}$.

6. To construct a line parallel to a given line through a point not on the line, follow the steps given:
Given: Line $I$ and point $P$ that is not on line $I$ Construct: The line parallel to line I through point $P$

Procedure:

Construct: Equilateral $\triangle A B C$ inscribed in circle $O$

1. Mark a point anywhere on the circle and label it point $P$.
2. Open the compass to the radius of circle $O$.
3. Place the compass point on point $P$ and draw an arc that intersects the circle at two points. Label the points $A$ and $B$.
4. Using a straightedge, draw $\overline{A B}$.
5. Open the compass to the length of $\overline{A B}$.
6. Place the compass point on $A$. Draw an arc from point $A$ that intersects the circle. Label this point $C$.
7. Using a straightedge, draw $\overline{A C}$ and $\overline{B C}$.
8. Equilateral $\triangle A B C$ is inscribed in circle $O$.

9. To construct a square inscribed in a circle, follow the steps given:

Given: Circle $O$


Construct: Square $A B C D$ inscribed in circle $O$
Procedure:

1. Mark a point anywhere on the circle and label it point $A$.

2. Using a straightedge, draw a diameter from point $A$. Label the other endpoint of the diameter as point $C$. This is diameter $\overline{A C}$.

3. Construct a perpendicular bisector of $\overline{A C}$ through the center of circle $O$. Label the points where it intersects the circle as point $B$ and point $D$.

4. Using a straightedge, draw $\overline{A B}, \overline{B C}, \overline{C D}$, and $\overline{A D}$.

5. Square $A B C D$ is inscribed in circle $O$.
6. To construct a regular hexagon inscribed in a circle, follow the steps given:

Given: Circle 0


Construct: Regular hexagon $A B C D E F$ inscribed in circle $O$

3. Place the compass point on point $A$ and draw an arc across the circle. Label this point $B$.

## Solution:

a. Draw point $T$. Draw $\overrightarrow{T S}$.


Place the point of a compass on point $C$. Draw an arc. Label the intersection points $X$ and $Y$. Keep the compass width the same, and place the point of the compass on point $T$. Draw an arc and label the intersection point $V$.


Place the point of the compass on point $Y$ and adjust the width to point $X$. Then place the point of the compass on point $V$ and draw an arc that intersects the first arc. Label the intersection point $U$.


Draw $\overrightarrow{T U}$ and point $R$ on $\overrightarrow{T U}$. Angle $B C D$ has now been copied to form angle RTS.

b. Connect points $X$ and $Y$ and points $U$ and $V$ to form $\triangle X C Y$ and $\triangle U T V . \overline{C Y}$ and $\overline{T V}, \overline{X Y}$ and $\overline{U V}$, and $\overline{C X}$ and $\overline{T U}$ are congruent because they were drawn with the same compass width. ## Solution:

Draw a point $P$ that is not on $\overline{M N}$. Place the compass point on point $P$. Draw an arc that intersects $\overline{M N}$ at two points. Label the intersections points $Q$ and $R$. Without changing the width of the compass, place the compass on point $Q$ and draw an arc under $\overline{M N}$. Place the compass on point $R$ and draw another arc under $\overline{M N}$. Label the intersection point $S$. Draw $\overline{P S}$. Segment $P S$ is perpendicular to and bisects $\overline{M N}$.

3. Construct equilateral $\triangle H J$ inscribed in circle $K$. Explain the steps you used to make your construction.

## Solution:

(This is an alternate method from the method shown in Key Idea 7.) Draw circle $K$. Draw segment $\overline{F G}$ through the center of circle $K$. Label the points where $\overline{F G}$ intersects circle $K$ as points $I$ and $P$. Using the compass setting you used when drawing the circle, place a compass on point $P$ and draw an arc passing through point $K$. Label the points where the arc intersects circle $K$ as points $H$ and $J$. Draw $\overline{H J}, \overline{I J}$, and $\overline{H I}$. Triangle $H I J$ is an equilateral triangle inscribed in circle $K$.


## Use Coordinates to Prove Simple Geometric Theorems Algebraically

(Focus on quadrilaterals, right triangles, and circles.)

## KEY IDEAS

1. To prove properties about special parallelograms on a coordinate plane, you can use the midpoint, distance, and slope formulas:

- The midpoint formula is $\left(\frac{x_{1}+x_{2}}{2}, \frac{y_{1}+y_{2}}{2}\right)$. This formula is used to find the coordinates of the midpoint of $\overline{A B}$, given $A\left(x_{1}, y_{1}\right)$ and $B\left(x_{2}, y_{2}\right)$.
- The distance formula is $d=\sqrt{\left(x_{2}-x_{1}\right)^{2}+\left(y_{2}-y_{1}\right)^{2}}$. This formula is used to find the length of $\overline{A B}$, given $A\left(x_{1}, y_{1}\right)$ and $B\left(x_{2}, y_{2}\right)$.
- The slope formula is $m=\left(\frac{y_{2}-y_{1}}{x_{2}-x_{1}}\right)$. This formula is used to find the slope of a line or line segment, given any two points on the line or line segment $A\left(x_{1}, y_{1}\right)$ and $B\left(x_{2}, y_{2}\right)$.

2. You can use properties of quadrilaterals to help prove theorems, such as the following:

- To prove a quadrilateral is a parallelogram, show that the opposite sides are parallel using slope.
- To prove a quadrilateral is a rectangle, show that the opposite sides are parallel and the consecutive sides are perpendicular using slope.
- To prove a quadrilateral is a rhombus, show that all four sides are congruent using the distance formula.
- To prove a quadrilateral is a square, show that all four sides are congruent and consecutive sides are perpendicular using slope and the distance formula.

3. You can also use diagonals of a quadrilateral to help prove theorems, such as the following:

- To prove a quadrilateral is a parallelogram, show that its diagonals bisect each other using the midpoint formula.
- To prove a quadrilateral is a rectangle, show that its diagonals bisect each other and are congruent using the midpoint and distance formulas.
- To prove a quadrilateral is a rhombus, show that its diagonals bisect each other and are perpendicular using the midpoint and slope formulas.
- To prove a quadrilateral is a square, show that its diagonals bisect each other, are congruent, and are perpendicular using the midpoint, distance, and slope formulas.


## Important Tips

\& When using the formulas for midpoint, distance, and slope, the order of the points does not matter. You can use either point to be ( $x_{1}, y_{1}$ ) and ( $x_{2}, y_{2}$ ), but be careful to always subtract in the same order.
\& Parallel lines have the same slope. Perpendicular lines have slopes that are the negative reciprocal of each other.

## REVIEW EXAMPLE

1. Quadrilateral $A B C D$ has vertices $A(-1,3), B(3,5), C(4,3)$, and $D(0,1)$. Is $A B C D$ a rectangle? Explain how you know.

## Solution:

First determine whether the figure is a parallelogram. If the figure is a parallelogram, then the diagonals bisect each other. If the diagonals bisect each other, then the midpoints of the diagonals are the same point. Use the midpoint formula to determine the midpoints for each diagonal.

Midpoint $\overline{A C}:\left(\frac{x_{1}+x_{2}}{2}, \frac{y_{1}+y_{2}}{2}\right)=\left(\frac{-1+4}{2}, \frac{3+3}{2}\right)=\left(\frac{3}{2}, \frac{6}{2}\right)=(1.5,3)$
Midpoint $\overline{B D}:\left(\frac{x_{1}+x_{2}}{2}, \frac{y_{1}+y_{2}}{2}\right)=\left(\frac{3+0}{2}, \frac{5+1}{2}\right)=\left(\frac{3}{2}, \frac{6}{2}\right)=(1.5,3)$
The diagonals have the same midpoint; therefore, the diagonals bisect each other and the figure is a parallelogram.

A parallelogram with congruent diagonals is a rectangle. Determine whether the diagonals are congruent.

Use the distance formula to find the length of the diagonals.

$$
\begin{aligned}
& A C=\sqrt{(4-(-1))^{2}+(3-3)^{2}}=\sqrt{(5)^{2}+(0)^{2}}=\sqrt{25+0}=\sqrt{25}=5 \\
& B D=\sqrt{(0-3)^{2}+(1-5)^{2}}=\sqrt{(-3)^{2}+(-4)^{2}}=\sqrt{9+16}=\sqrt{25}=5
\end{aligned}
$$

The diagonals are congruent because they have the same length.
The figure is a parallelogram with congruent diagonals, so the figure is a rectangle.

## UNIT 3: RIGHT TRIANGLE TRIGONOMETRY

This unit investigates the properties of right triangles. The trigonometric ratios sine, cosine, and tangent along with the Pythagorean theorem are used to solve right triangles in applied problems. The relationship between the sine and cosine of complementary angles is identified.

## Right Triangle Relationships

MGSE9-12.G.SRT. 6 Understand that by similarity, side ratios in right triangles are properties of the angles in the triangle, leading to definitions of trigonometric ratios for acute angles.

MGSE9-12.G.SRT. 7 Explain and use the relationship between the sine and cosine of complementary angles.

MGSE9-12.G.SRT. 8 Use trigonometric ratios and the Pythagorean theorem to solve right triangles in applied problems.

## KEY IDEAS

1. The trigonometric ratios sine, cosine, and tangent are defined as ratios of the lengths of the sides in a right triangle with a given acute angle measure. These terms are usually seen abbreviated as sin, cos, and tan.


Adjacent

- $\sin \theta=\frac{\text { length of opposite side }}{\text { length of hypotenuse }}$
- $\cos \theta=\frac{\text { length of adjacent side }}{\text { length of hypotenuse }}$
- $\tan \theta=\frac{\text { length of opposite side }}{\text { length of adjacent side }}$

- $\sin A=\frac{\text { length of opposite side }}{\text { length of hypotenuse }}$
- $\cos A=\frac{\text { length of adjacent side }}{\text { length of hypotenuse }}$
- $\tan A=\frac{\text { length of opposite side }}{\text { length of adjacent side }}$

2. The two acute angles of any right triangle are complementary. As a result, if angles $P$ and $Q$ are complementary, $\sin P=\cos Q$ and $\sin Q=\cos P$.
3. When solving problems with right triangles, you can use both trigonometric ratios and the Pythagorean theorem $\left(a^{2}+b^{2}=c^{2}\right)$. There may be more than one way to solve the problem, so analyze the given information to help decide which method is the most efficient.

## Important Tip

25 The tangent of angle $A$ is also equivalent to $\frac{\sin A}{\cos A}$.

## REVIEW EXAMPLES

1. Triangles $A B C$ and $D E F$ are similar.

a. Find the ratio of the side opposite angle $B$ to the hypotenuse in $\triangle A B C$.
b. What angle in $\triangle D E F$ corresponds to angle $B$ ?
c. Find the ratio of the side opposite angle $E$ to the hypotenuse in $\triangle D E F$.
d. How does the ratio in part (a) compare to the ratio in part (c)?
e. Which trigonometric ratio does this represent?

## Solution:

a. $\overline{A C}$ is opposite angle $B . \overline{B C}$ is the hypotenuse. The ratio of the side opposite angle $B$ to the hypotenuse in $\triangle A B C$ is $\frac{8}{10}=\frac{4}{5}$.
b. Angle $E$ in $\triangle D E F$ corresponds to angle $B$ in $\triangle A B C$.
c. $\overline{D F}$ is opposite angle $E . \overline{E F}$ is the hypotenuse. The ratio of the side opposite angle $E$ to the hypotenuse in $\triangle D E F$ is $\frac{4}{5}$.
d. The ratios are the same.
e. This represents $\sin B$ and $\sin E$, because both are the ratio $\frac{\text { opposite }}{\text { hypotenuse }}$.
2. Ricardo is standing 75 feet away from the base of a building. The angle of elevation from the ground where Ricardo is standing to the top of the building is $32^{\circ}$.

\sin 32^{\circ}=0.5299 \\
\cos 32^{\circ}=0.8480 \\
\tan 32^{\circ}=0.6249
\end{array}\right]
$$

## Solution:

You want to know the length of the side opposite the $32^{\circ}$ angle, and you know the length of the side adjacent to the $32^{\circ}$ angle. So, use the tangent ratio. Substitute $x$ for the opposite side, 75 for the adjacent side, and $32^{\circ}$ for the angle measure.
Then solve.

$$
\begin{aligned}
\tan 32^{\circ} & =\frac{x}{75} \\
75 \tan 32^{\circ} & =x \\
75 \cdot 0.6249 & \approx x \\
46.9 & \approx x
\end{aligned}
$$

The building is about 46.9 feet tall.
3. An airplane is at an altitude of 5,900 feet. The airplane descends at an angle of $3^{\circ}$.


Note: Figure not drawn to scale.
About how far will the airplane travel in the air until it reaches the ground?

$$
\left[\begin{array}{l}
\sin 3^{\circ}=0.0523 \\
\cos 3^{\circ}=0.9986 \\
\tan 3^{\circ}=0.0524
\end{array}\right]
$$

## Solution:

Use $\sin 3^{\circ}$ to find the distance the airplane will travel until it reaches the ground, $x$. Substitute $x$ for the hypotenuse, 5,900 for the opposite side, and $3^{\circ}$ for the angle measure. Then solve.

$$
\begin{aligned}
\sin 3^{\circ} & =\frac{5,900}{x} \\
x & =\frac{5,900}{\sin 3^{\circ}} \\
x & \approx \frac{5,900}{0.0523} \\
x & \approx 112,811
\end{aligned}
$$

The airplane will travel about 113,000 feet until it reaches the ground.
4. Triangle $A B C$ is a right triangle.


What is the best approximation for $m \angle C$ ?

$$
\left[\begin{array}{c}
\sin 67.4^{\circ} \approx 0.923 \\
\cos 22.6^{\circ} \approx 0.923 \\
\tan 42.7^{\circ} \approx 0.923

## Solution:

Find the trigonometric ratios for angle $C$.
$\sin C=\frac{5}{13} \approx 0.385$
$\cos C=\frac{12}{13} \approx 0.923$
$\tan C=\frac{5}{12} \approx 0.417$
Using the table, $\cos 22.6^{\circ} \approx 0.923$, so $m \angle C \approx 22.6^{\circ}$, or using trigonometric inverses, $\sin ^{-1} \frac{5}{13}=22.6, \cos ^{-1}=\frac{12}{13}=22.6$, or $\tan ^{-1} \frac{5}{12}=22.6$.

## UNIT 4: CIRCLES AND VOLUME

This unit investigates the properties of circles and addresses finding the volume of solids. Properties of circles are used to solve problems involving arcs, angles, sectors, chords, tangents, and secants. Volume formulas are derived and used to calculate the volumes of cylinders, pyramids, cones, and spheres.

## Understand and Apply Theorems about Circles

MGSE9-12.G.C. 1 Understand that all circles are similar.
MGSE9-12.G.C. 2 Identify and describe relationships among inscribed angles, radii, chords, tangents, and secants. Include the relationship between central, inscribed, and circumscribed angles; inscribed angles on a diameter are right angles; the radius of a circle is perpendicular to the tangent where the radius intersects the circle.

MGSE9-12.G.C. 3 Construct the inscribed and circumscribed circles of a triangle, and prove properties of angles for a quadrilateral inscribed in a circle.

MGSE9-12.G.C. 4 Construct a tangent line from a point outside a given circle to the circle.

## KEY IDEAS

1. A circle is the set of points in a plane equidistant from a given point, which is the center of the circle. All circles are similar.
2. A radius is a line segment from the center of a circle to any point on the circle. The word radius is also used to describe the length, $r$, of the segment. $\overline{A B}$ is a radius of circle $A$.

3. A chord is a line segment whose endpoints are on a circle. $\overline{B C}$ is a chord of circle $A$.

4. A diameter is a chord that passes through the center of a circle. The word diameter is also used to describe the length, $d$, of the segment. $\overline{B C}$ is a diameter of circle $A$.

5. A secant line is a line that is in the plane of a circle and intersects the circle at exactly two points. Every chord lies on a secant line. $\overparen{B C}$ is a secant line of circle $A$.

6. A tangent line is a line that is in the plane of a circle and intersects the circle at only one point, the point of tangency. $\overparen{D F}$ is tangent to circle $A$ at the point of tangency, point $D$.

7. If a line is tangent to a circle, the line is perpendicular to the radius drawn to the point of tangency. $\overleftrightarrow{D F}$ is tangent to circle $A$ at point $D$, so $\overline{A D} \perp \overline{D F}$.

8. Tangent segments drawn from the same point are congruent. In circle $A, \overline{C G} \cong \overline{B G}$.

9. Circumference is the distance around a circle. The formula for circumference $C$ of a circle is $C=\pi d$, where $d$ is the diameter of the circle. The formula is also written as $C=2 \pi r$, where $r$ is the length of the radius of the circle. $\pi$ is the ratio of circumference to diameter of any circle.
10. An arc is a part of the circumference of a circle. A minor arc has a measure less than $180^{\circ}$. Minor arcs are written using two points on a circle. A semicircle is an arc that measures exactly $180^{\circ}$. Semicircles are written using three points on a circle. This is done to show which half of the circle is being described. A major arc has a measure greater than $180^{\circ}$. Major arcs are written with three points to distinguish them from the corresponding minor arc. In circle $A, \overparen{C B}$ is a minor arc, $\widehat{C B D}$ is a semicircle, and $\widehat{C D B}$ is a major arc.

11. A central angle is an angle whose vertex is at the center of a circle and whose sides are radii of the circle. The measure of a central angle of a circle is equal to the measure of the intercepted arc. $\angle A P B$ is a central angle for circle $P$, and $\overparen{A B}$ is the intercepted arc.

12. An inscribed angle is an angle whose vertex is on a circle and whose sides are chords of the circle. The measure of an angle inscribed in a circle is half the measure of the intercepted arc. For circle $D, \angle A B C$ is an inscribed angle, and $\overparen{A C}$ is the intercepted arc.


$$
\begin{gathered}
m \angle A B C=\frac{1}{2} m \overparen{A C}=\frac{1}{2} m \angle A D C \\
m \angle A D C=m \overparen{A C}=2(m \angle A B C)
\end{gathered}
$$

13. A circumscribed angle is an angle formed by two rays that are each tangent to a circle. These rays are perpendicular to radii of the circle. In circle $O$, the measure of the circumscribed angle is equal to $180^{\circ}$ minus the measure of the central angle that forms the intercepted arc. The measure of the circumscribed angle can also be found by using the measures of two intercepted arcs [see Key Idea 18].


$$
m \angle A B C=180^{\circ}-m \angle A O C
$$

14. When an inscribed angle intercepts a semicircle, the inscribed angle has a measure of $90^{\circ}$. For circle $0, \angle R P Q$ intercepts semicircle $R S Q$ as shown.


$$
m \angle R P Q=\frac{1}{2}(m \overparen{R S Q})=\frac{1}{2}\left(180^{\circ}\right)=90^{\circ}
$$

15. The measure of an angle formed by a tangent and a chord with its vertex on the circle is half the measure of the intercepted arc. $\overline{A B}$ is a chord for the circle, and $\overrightarrow{B C}$ is tangent to the circle at point $B$. So, $\angle A B C$ is formed by a tangent and a chord.

16. When two chords intersect inside a circle, two pairs of vertical angles are formed. The measure of any one of the angles is half the sum of the measures of the arcs intercepted by the pair of vertical angles.


$$
\begin{aligned}
& m \angle A B E=\frac{1}{2}(m \overparen{A E}+m \overparen{C D}) \\
& m \angle A B D=\frac{1}{2}(m \overparen{A F D}+m \overparen{E C})
\end{aligned}
$$

17. When two chords intersect inside a circle, the product of the lengths of the segments of one chord is equal to the product of the lengths of the segments of the other chord.


$$
A B \cdot B C=E B \cdot B D
$$

18. Angles outside a circle can be formed by the intersection of two tangents (circumscribed angle), two secants, or a secant and a tangent. For all three situations, the measure of the angle is half the difference of the measure of the larger intercepted arc and the measure of the smaller intercepted arc.

$m \angle A B D=\frac{1}{2}(m \overparen{A F D}-m \overparen{A D})$
$m \angle A C E=\frac{1}{2}(m \overparen{A E}-m \overparen{B D})$
$m \angle A B D=\frac{1}{2}(m \overparen{A D}-m \overparen{A C})$
19. When two secant segments intersect outside a circle, part of each secant segment is a segment formed outside the circle. The product of the length of one secant segment and the length of the segment formed outside the circle is equal to the product of the length of the other secant segment and the length of the segment formed outside the circle.


$$
E C \cdot D C=A C \cdot B C
$$

20. When a secant segment and a tangent segment intersect outside a circle, the product of the length of the secant segment and the length of the segment formed outside the circle is equal to the square of the length of the tangent segment.


$$
D B \cdot C B=A B^{2}
$$

21. An inscribed polygon is a polygon whose vertices all lie on a circle. This diagram shows a triangle, a quadrilateral, and a pentagon each inscribed in a circle.

22. In a quadrilateral inscribed in a circle, the opposite angles are supplementary.


$$
\begin{aligned}
& m \angle A B C+m \angle A D C=180^{\circ} \\
& m \angle B C D+m \angle B A D=180^{\circ}
\end{aligned}
$$

23. When a triangle is inscribed in a circle, the center of the circle is the circumcenter of the triangle. The circumcenter is equidistant from the vertices of the triangle.
Triangle $A B C$ is inscribed in circle $Q$, and point $Q$ is the circumcenter of the triangle.

\boldsymbol{C} \\
A Q=B Q=C Q
\end{gathered}
$$

24. An inscribed circle is a circle enclosed in a polygon, where every side of the polygon is tangent to the circle. Specifically, when a circle is inscribed in a triangle, the center of the circle is the incenter of the triangle. The incenter is equidistant from the sides of the triangle. Circle $Q$ is inscribed in triangle $A B C$, and point $Q$ is the incenter of the triangle. Notice also that the sides of the triangle form circumscribed angles with the circle.

1. $\angle P N Q$ is inscribed in circle $O$ and $m \overparen{P Q}=70^{\circ}$.

a. What is the measure of $\angle P O Q$ ?
b. What is the relationship between $\angle P O Q$ and $\angle P N Q$ ?

## Solution:

a. The measure of a central angle is equal to the measure of the intercepted arc. $m \angle P O Q=m \overparen{P Q}=70^{\circ}$.
b. $\angle P O Q$ is a central angle that intercepts $\overparen{P Q}$. $\angle P N Q$ is an inscribed angle that intercepts $\overparen{P Q}$. The measure of the central angle is equal to the measure of the intercepted arc. The measure of the inscribed angle is equal to one-half the measure of the intercepted arc. So $m \angle P O Q=m \overparen{P Q}$ and $m \angle P N Q=\frac{1}{2} m \overparen{P Q}$, so $m \angle P O Q=2 m \angle P N Q$.
c. From part (b), $m \angle P O Q=2 m \angle P N Q$

Substitute: $\quad 70^{\circ}=2 m \angle P N Q$
Divide: $\quad 35^{\circ}=m \angle P N Q$
2. In circle $P$ below, $\overline{A B}$ is a diameter.


If $m \angle A P C=100^{\circ}$, find the following:
a. $m \angle B P C$
b. $m \angle B A C$
c. $m \overparen{B C}$
d. $m \overparen{A C}$

## Solution:

a. $\angle A P C$ and $\angle B P C$ are supplementary, so $m \angle B P C=180^{\circ}-m \angle A P C$, so $m \angle B P C=180^{\circ}-100^{\circ}=80^{\circ}$.
b. $\angle B A C$ is an angle in $\triangle A P C$. The sum of the measures of the angles of a triangle is $180^{\circ}$.

For $\triangle A P C$ : $m \angle A P C+m \angle B A C+m \angle A C P=180^{\circ}$
You are given that $m \angle A P C=100^{\circ}$.
Substitute: $100^{\circ}+m \angle B A C+m \angle A C P=180^{\circ}$
Subtract $100^{\circ}$ from both sides: $m \angle B A C+m \angle A C P=80^{\circ}$
Because two sides of $\triangle A P C$ are radii of the circle, $\triangle A P C$ is an isosceles
triangle. This means that the two base angles are congruent, so
$m \angle B A C=m \angle A C P$.
Substitute: $m \angle B A C$ for $m \angle A C P: m \angle B A C+m \angle B A C=80^{\circ}$
Add: $2 m \angle B A C=80^{\circ}$
Divide: $m \angle B A C=40^{\circ}$
You could also use the answer from part (a) to solve for $m \angle B A C$. Part (a) shows $m \angle B P C=80^{\circ}$.

Because the central angle measure is equal to the measure of the intercepted arc, $m \angle B P C=m \overparen{B C}=80^{\circ}$.

Because an inscribed angle is equal to one-half the measure of the intercepted arc, $m \angle B A C=\frac{1}{2} m \overparen{B C}$.
By substitution: $m \angle B A C=\frac{1}{2}\left(80^{\circ}\right)$

Therefore, $m \angle B A C=40^{\circ}$.
c. $\angle B A C$ is an inscribed angle intercepting $\overparen{B C}$. The intercepted arc is twice the measure of the inscribed angle.
$m \overparen{B C}=2 m \angle B A C$
From part (b), $m \angle B A C=40^{\circ}$.
Substitute: $m \overparen{B C}=2 \cdot 40^{\circ}$
$m \overparen{B C}=80^{\circ}$
You could also use the answer from part (a) to solve. Part (a) shows $m \angle B P C=80^{\circ}$. Because $\angle B P C$ is a central angle that intercepts $\overparen{B C}, m \angle B P C=m \overparen{B C}=80^{\circ}$.
d. $\angle A P C$ is a central angle intercepting $\overparen{A C}$. The measure of the intercepted arc is equal to the measure of the central angle.
$m \overparen{A C}=m \angle A P C$
You are given $m \angle A P C=100^{\circ}$.
Substitute: $m \overparen{A C}=100^{\circ}$
3. In circle $P$ below, $\overline{D G}$ is a tangent. $A F=8, E F=6, B F=4$, and $E G=8$.


Find $C F$ and $D G$.

## Solution:

First, find $C F$. Use the fact that $\overline{C F}$ is part of a pair of intersecting chords.

$$
\begin{aligned}
\mathrm{AF} \cdot \mathrm{CF} & =\mathrm{EF} \cdot \mathrm{BF} \\
8 \cdot C F & =6 \cdot 4 \\
8 \cdot C F & =24 \\
C F & =3
\end{aligned}
$$

Next, find $D G$. Use the fact that $\overline{D G}$ is tangent to the circle.

$$
\begin{aligned}
E G \cdot B G & =D G^{2} \\
8 \cdot(8+6+4) & =D G^{2} \\
8 \cdot 18 & =D G^{2} \\
144 & =D G^{2} \\
\pm 12 & =D G \\
12 & =D G \text { (since length cannot be negative) }
\end{aligned}
$$

$C F=3$ and $D G=12$.
4. In this circle, $\overline{A B}$ is tangent to the circle at point $B, \overline{A C}$ is tangent to the circle at point $C$, and point $D$ lies on the circle. What is $m \angle B A C$ ?


## Solution:

## Method 1

First, find the measure of angle BOC. Angle BDC is an inscribed angle, and angle $B O C$ is a central angle.

$$
\begin{aligned}
m \angle B O C & =2 \cdot m \angle B D C \\
& =2 \cdot 48^{\circ} \\
& =96^{\circ}
\end{aligned}
$$

Angle $B A C$ is a circumscribed angle. Use the measure of angle BOC to find the measure of angle $B A C$.

$$
\begin{aligned}
m \angle B A C & =180^{\circ}-m \angle B O C \\
& =180^{\circ}-96^{\circ} \\
& =84^{\circ}
\end{aligned}
$$

## Method 2

Angle $B D C$ is an inscribed angle. First, find the measures of $\overparen{B C}$ and $\overparen{B D C}$.

$$
\begin{aligned}
m \angle B D C & =\frac{1}{2} \cdot m \overparen{B C} \\
48^{\circ} & =\frac{1}{2} \cdot m \overparen{B C} \\
2 \cdot 48^{\circ} & =m \overparen{B C} \\
96^{\circ} & =m \overparen{B C} \\
m \overparen{B D C} & =360^{\circ}-m \overparen{B C} \\
& =360^{\circ}-96^{\circ} \\
& =264^{\circ}
\end{aligned}
$$

Angle $B A C$ is a circumscribed angle. Use the measures of $\overparen{B C}$ and $\overparen{B D C}$ to find the measure of angle BAC.

$$
\begin{aligned}
m \angle B A C & =\frac{1}{2}(m \overparen{B D C}-m \overparen{B C}) \\
& =\frac{1}{2}\left(264^{\circ}-96^{\circ}\right) \\
& =\frac{1}{2}\left(168^{\circ}\right) \\
& =84^{\circ}
\end{aligned}
$$

## Find Arc Lengths and Areas of Sectors of Circles

MGSE9-12.G.C. 5 Derive using similarity the fact that the length of the arc intercepted by an angle is proportional to the radius, and define the radian measure of the angle as the constant of proportionality; derive the formula for the area of a sector.

## KEY IDEAS

1. Circumference is the distance around a circle. The formula for the circumference, $C$, of a circle is $C=2 \pi r$, where $r$ is the length of the radius of the circle.
2. Area is a measure of the amount of space a circle covers. The formula for the area, $A$, of a circle is $A=\pi r^{2}$, where $r$ is the length of the radius of the circle.
3. Arc length is a portion of the circumference of a circle. To find the length of an arc, divide the number of degrees in the central angle of the arc by 360, and then multiply that amount by the circumference of the circle. The formula for the arc length, $s$, is $s=\frac{2 \pi r \theta}{360}$, where $\theta$ is the degree measure of the central angle and $r$ is the radius of the circle.


## Important Tip

2. Do not confuse arc length with the measure of the arc in degrees. Arc length depends on the size of the circle because it is part of the circumference of the circle. The measure of the arc is independent of (does not depend on) the size of the circle.

One way to remember the formula for arc length:
arc length $=$ fraction of the circle $\times$ circumference $=s=\frac{2 \pi r \theta}{360}$.
4. A sector of a circle is the region bounded by two radii of a circle and the resulting arc between them. To find the area of a sector, divide the number of degrees in the central angle of the arc by 360, and then multiply that amount by the area of the circle. The formula for area of sector $=\frac{\pi r^{2} \theta}{360}$, where $\theta$ is the degree measure of the central angle and $r$ is the radius of the circle.


## Important Tip

es One way to remember the formula for area of a sector:
area of a sector $=$ fraction of the circle $\times$ area $=\frac{\theta}{360}\left(\pi r^{2}\right)$.

## REVIEW EXAMPLES

## Solution:

a. Divide the radius of circle $B$ by the radius of circle $A$ : $\frac{\text { circle } B}{\text { circle } A}=\frac{10}{7}$
b. Divide the length of the intercepted arc of circle $B$ by the length of the intercepted arc of circle A:

$$
\frac{\frac{50}{9} \pi}{\frac{35}{9} \pi}=\frac{50 \pi}{9} \cdot \frac{9}{35 \pi}=\frac{10}{7}
$$

c. The ratios are the same.
d. Divide the radius of circle $C$ by the radius of circle $B: \frac{\text { circle } C}{\text { circle } B}=\frac{12}{10}=\frac{6}{5}$
e. Divide the length of the intercepted arc of circle $C$ by the length of the
intercepted arc of circle $B: \frac{\frac{20}{3} \pi}{\frac{50}{9} \pi}=\frac{20 \pi}{3} \cdot \frac{9}{50 \pi}=\frac{6}{5}$
f. The ratios are the same.
g. When circles, such as circles $A, B$, and $C$, have the same central angle measure, the ratio of the lengths of the intercepted arcs is the same as the ratio of the radii.
h. Circle $A: \frac{\frac{35}{9} \pi}{7}=\frac{35}{63} \pi=\frac{5}{9} \pi$

Circle $B: \frac{\frac{50}{9} \pi}{10}=\frac{50}{90} \pi=\frac{5}{9} \pi$
Circle C: $\frac{\frac{20}{3} \pi}{12}=\frac{20}{36} \pi=\frac{5}{9} \pi$
2. Circle $A$ is shown.


If $x=50$, what is the area of the shaded sector of circle $A$ ?

## Solution:

To find the area of the sector, divide the measure of the central angle of the arc in degrees by 360, and then multiply that amount by the area of the circle. The arc measure, $x$, is equal to the measure of the central angle, $\theta$. The formula for the area of a circle is $A=\pi r^{2}$.
$A_{\text {sector }}=\frac{\pi r^{2} \theta}{360}$
$A_{\text {sector }}=\frac{50 \pi(8)^{2}}{360} \quad$ Substitute 50 for $\theta$ and 8 for $r$.
$A_{\text {sector }}=\frac{5 \pi(64)}{36} \quad$ Rewrite the fraction and the power.
$A_{\text {sector }}=\frac{320 \pi}{36} \quad$ Multiply.
$A_{\text {sector }}=\frac{80 \pi}{9} \quad$ Rewrite.
The area of the sector is $\frac{80}{9} \pi$ square meters.

## KEY IDEAS

1. The volume of a figure is a measure of how much space it takes up. Volume is a measure of capacity.
2. The formula for the volume of a cylinder is $V=\pi r^{2} h$, where $r$ is the radius and $h$ is the height. The volume formula can also be given as $V=B h$, where $B$ is the area of the base. In a cylinder, the base is a circle and the area of a circle is given by $A=\pi r^{2}$. Therefore, $V=B h=\pi r^{2} h$.

3. When a cylinder and a cone have congruent bases and equal heights, the volume of exactly three cones will fit into the cylinder. So, for a cone and cylinder that have the same radius $r$ and height $h$, the volume of the cone is one-third of the volume of the cylinder.
The formula for the volume of a cone is $V=\frac{1}{3} \pi r^{2} h$, where $r$ is the radius and $h$ is
the height. the height.

4. The formula for the volume of a pyramid is $V=\frac{1}{3} B h$, where $B$ is the area of the base and $h$ is the height.

5. The formula for the volume of a sphere is $V=\frac{4}{3} \pi r^{3}$, where $r$ is the radius.

6. Cavalieri's principle states that if two solids are between parallel planes and all cross sections at equal distances from their bases have equal areas, the solids have equal volumes. For example, this cone and this pyramid have the same height and the cross sections have the same area, so they have equal volumes.


## REVIEW EXAMPLES

1. What is the volume of the cone shown below?


## Solution:

The diameter of the cone is 16 cm . So the radius is $16 \mathrm{~cm} \div 2=8 \mathrm{~cm}$. Use the Pythagorean theorem, $a^{2}+b^{2}=c^{2}$, to find the height of the cone. Substitute 8 for $b$ and 17 for $c$ and solve for $a$ :

$$
\begin{aligned}
a^{2}+8^{2} & =17^{2} \\
a^{2}+64 & =289 \\
a^{2} & =225 \\
a & =15
\end{aligned}
$$

The formula for the volume of a cone is $V=\frac{1}{3} \pi r^{2} h$. Substitute 8 for $r$ and 15 for $h$ :

$$
\begin{equation*}
V=\frac{1}{3} \pi r^{2} h=\frac{1}{3} \pi(8)^{2} \tag{15}
\end{equation*}
$$

The volume is $320 \pi \mathrm{~cm}^{3}$.
2. A sphere has a radius of 3 feet. What is the volume of the sphere?

## Solution:

The formula for the volume of a sphere is $V=\frac{4}{3} \pi r^{3}$. Substitute 3 for $r$ and solve.

$$
\begin{aligned}
V & =\frac{4}{3} \pi r^{3} \\
V & =\frac{4}{3} \pi(3)^{3} \\
V & =\frac{4}{3} \pi(27) \\
V & =36 \pi \mathrm{ft}^{3}
\end{aligned}
$$

3. A cylinder has a radius of 10 cm and a height of 9 cm . A cone has a radius of 10 cm and a height of 9 cm . Show that the volume of the cylinder is three times the volume of the cone.

## Solution:

The formula for the volume of a cylinder is $V=\pi r^{2} h$. Substitute 10 for $r$ and 9 for $h$ :

$$
\begin{aligned}
V & =\pi r^{2} h \\
& =\pi(10)^{2}(9) \\
& =\pi(100)(9) \\
& =900 \pi \mathrm{~cm}^{3}
\end{aligned}
$$

The formula for the volume of a cone is $V=\frac{1}{3} \pi r^{2} h$. Substitute 10 for $r$ and 9 for $h$ :

$$
\begin{aligned}
V & =\frac{1}{3} \pi r^{2} h \\
& =\frac{1}{3} \pi(10)^{2}(9) \\
& =\frac{1}{3} \pi(100)(9) \\
& =300 \pi \mathrm{~cm}^{3}
\end{aligned}
$$

Divide: $900 \pi \div 300 \pi=3$
4. Cylinder A and Cylinder B are shown below. What is the volume of each cylinder?


## Solution:

To find the volume of Cylinder A, use the formula for the volume of a cylinder, which is $V=\pi r^{2} h$. Divide the diameter by 2 to find the radius: $10 \div 2=5$. Substitute 5 for $r$ and 12 for $h$ :

$$
\begin{aligned}
V_{\text {Cylinder } \mathrm{A}} & =\pi r^{2} h \\
& =\pi(5)^{2}(12) \\
& =\pi(25)(12) \\
& =300 \pi \mathrm{~m}^{3} \\
& \approx 942 \mathrm{~m}^{3}
\end{aligned}
$$

Notice that Cylinder B has the same height and the same radius as Cylinder A. The only difference is that Cylinder B is slanted. For both cylinders, the cross section at every plane parallel to the bases is a circle with the same area. By Cavalieri's principle, the cylinders have the same volume; therefore, the volume of Cylinder B is $300 \pi \mathrm{~m}^{3}$, or about $942 \mathrm{~m}^{3}$.


Cylinder A


Cylinder B

## UNIT 5: GEOMETRIC AND ALGEBRAIC CONNECTIONS

This unit investigates coordinate geometry. Students look at equations for circles and use given information to derive equations for representations of these figures on a coordinate plane. Students also use coordinates to prove simple geometric theorems using the properties of distance, slope, and midpoints. Students will verify whether a figure is a special quadrilateral by showing that sides of figures are parallel or perpendicular.

## Apply Geometric Concepts in Modeling Situations

MGSE9-12.G.MG. 1 Use geometric shapes, their measures, and their properties to describe objects (e.g., modeling a tree trunk or a human torso as a cylinder).

## KEY IDEAS

1. Modeling can be applied to describe real-life objects with geometric shapes.
2. Density is the mass of an object divided by its volume.
3. Population density can be determined by calculating the quotient of the number of people in an area and the area itself.
4. Apply constraints to maximize or minimize the cost of a cardboard box used to package a product that represents a geometric figure. Apply volume relationships of cylinders, pyramids, cones, and spheres.

## REVIEW EXAMPLE

1. A city has a population of 6,688 people. The area of the city is approximately 7.267 square miles.

How many people per square mile live in the city?
Solution: Find the quotient of 6,688 and 7.267 to find the number of people per square mile in the city.

People per square mile $=\frac{6688}{7.267} \approx 920$ people per square mile
2. This is a hand drawing of a mountain.


Explain which geometric shape could be used to estimate the total amount of Earth the mountain is made of.

## Solution:

The most accurate shape that could be used to model the mountain is a cone because, to determine the total amount of Earth the mountain is made from, a 3 -dimensional shape is needed, which is why a triangle is not as accurate as a cone.
3. A construction company is preparing 10 acres of land for a new housing community. The land contains large rocks that need to be removed. A machine removes 10 rocks from 360 square feet of land.

## 1 acre $=43,560$ square feet

About how many rocks will need to be removed from the 10 acres of land?

## Solution:

If there are 10 rocks in 360 square feet, then we can predict that there will be about 10 rocks every 360 square feet of land.

We will need to determine how many 360 square feet are in 10 acres.
$10(43,560)=435,600$, so 435,600 square feet are in 10 acres.
$435,600 / 360=1,210$, so 1,210 parcels of 360 square feet are on the 10 acres.
$(1,210)(10)=12,100$
There should be about 12,100 rocks on the 10 acres of land.
4. A company needs to package this bell in a rectangular box.


What are the smallest dimensions (length, width, and height) the rectangular box can have so that the lid of the box can also close?

## Solution:

Since the diameter of the base of the cone is 6 inches, the width and length of the box cannot be smaller than 6 inches. Since the height of the cone is 8 inches, then the height of the box cannot be smaller than 8 inches.

This gives us a rectangular box with these dimensions:
Length $=6$ inches
Width $=6$ inches
Height $=8$ inches

The space inside the box around the pyramid is then filled with protective foam. About how many cubic inches of foam is needed to fill the space around the pyramid?

D. 125 cubic inches

Correct Answer: C

## Translate Between the Geometric Description and the Equation for a Conic Section

MGSE9-12.G.GPE. 1 Derive the equation of a circle of given center and radius using the Pythagorean Theorem; complete the square to find the center and radius of a circle given by an equation.

## KEY IDEAS

1. A circle is the set of points in a plane equidistant from a given point, or center, of the circle.
2. The standard form of the equation of a circle is $(x-h)^{2}+(y-k)^{2}=r^{2}$, where $(h, k)$ is the center of the circle and $r$ is the radius of the circle.

3. The equation of a circle can be derived from the Pythagorean Theorem.

## Example:

Given a circle with a center at $(h, k)$ and a point $(x, y)$ on the circle, draw a horizontal line segment from ( $h, k$ ) to $(x, k)$. Label this line segment $a$. Draw a vertical line segment from $(x, y)$ to $(x, k)$. Label this line segment $b$. Label the radius c. A right triangle is formed.

The length of line segment $a$ is given by $(x-h)$.
The length of line segment $b$ is given by $(y-k)$.


Using the Pythagorean Theorem, substitute $(x-h)$ for $a,(y-k)$ for $b$, and $r$ for $c$ in the equation.

$$
\begin{aligned}
a^{2}+b^{2} & =c^{2} & & \text { Use the Pythagorean Theorem. } \\
(x-h)^{2}+(y-k)^{2} & =r^{2} & & \text { Substitution }
\end{aligned}
$$

The equation for a circle with a center at $(h, k)$ and a radius $r$ is $(x-h)^{2}+(y-k)^{2}=r^{2}$.

## REVIEW EXAMPLES

1. What is the equation of the circle with a center at $(4,5)$ and a radius of 2 ?


## Solution:

Use the standard form for the equation for a circle, $(x-h)^{2}+(y-k)^{2}=r^{2}$. Substitute the values into the equation, with $h=4, k=5$, and $r=2$.

$$
\begin{aligned}
(x-h)^{2}+(y-k)^{2} & =r^{2} & & \text { Equation for a circle } \\
(x-(4))^{2}+(y-(5))^{2} & =(2)^{2} & & \text { Substitute the values in the equation of a circle. } \\
(x-4)^{2}+(y-5)^{2} & =4 & & \text { Evaluate. }
\end{aligned}
$$

The equation of a circle with a center at $(4,5)$ and a radius of 2 is $(x-4)^{2}+(y-5)^{2}=4$, or $x^{2}+y^{2}-8 x-10 y+37=0$ when expanded.
2. What is the center and radius of the circle given by $8 x^{2}+8 y^{2}-16 x-32 y+24=0$ ?

## Solution:

Write the equation in standard form to identify the center and radius of the circle. First, write the equation so the $x$-terms are next to each other and the $y$-terms are next to each other, both on the left side of the equation, and the constant term is on the right side of the equation.

$$
\begin{aligned}
8 x^{2}+8 y^{2}-16 x-32 y+24 & =0 & & \text { Original equation } \\
8 x^{2}+8 y^{2}-16 x-32 y & =-24 & & \text { Subtract } 24 \text { from both sides. } \\
8 x^{2}-16 x+8 y^{2}-32 y & =-24 & & \text { Commutative Property } \\
x^{2}-2 x+y^{2}-4 y & =-3 & & \text { Divide both sides by } 8 . \\
\left(x^{2}-2 x\right)+\left(y^{2}-4 y\right) & =-3 & & \text { Associative Property }
\end{aligned}
$$

Next, to write the equation in standard form, complete the square for the $x$-terms and the $y$-terms. Using $a x^{2}+b x+c=0$, find $\left(\frac{b}{2 a}\right)^{2}$ for the $x$ - and $y$-terms.

\left(x^{2}-2 x+1\right)+\left(y^{2}-4 y+4\right)=-3+1+4 \quad \text { Add } 1 \text { and } 4 \text { to each side of }

$(x-1)^{2}+(y-2)^{2}=2 \quad$ Write the trinomials as squares of binomials.

This equation for the circle is written in standard form, where $h=1, k=2$, and $r^{2}=2$. The center of the circle is $(1,2)$ and the radius is $\sqrt{2}$.

## Use Coordinates to Prove Simple Geometric Theorems Algebraically

MGSE9-12.G.GPE. 4 Use coordinates to prove simple geometric theorems algebraically. For example, prove or disprove that a figure defined by four given points in the coordinate plane is a rectangle; prove or disprove that the point $(1, \sqrt{3})$ lies on the circle centered at the origin and containing the point $(0,2)$.

MGSE9-12.G.GPE. 5 Prove the slope criteria for parallel and perpendicular lines and use them to solve geometric problems (e.g., find the equation of a line parallel or perpendicular to a given line that passes through a given point).

MGSE9-12.G.GPE. 6 Find the point on a directed line segment between two given points that partitions the segment in a given ratio.

MGSE9-12.G.GPE. 7 Use coordinates to compute perimeters of polygons and areas of triangles and rectangles, e.g., using the distance formula.

## KEY IDEAS

1. Given the equation of a circle, you can verify whether a point lies on the circle by substituting the coordinates of the point into the equation. If the resulting equation is true, then the point lies on the figure. If the resulting equation is not true, then the point does not lie on the figure.
2. Given the center and radius of a circle, you can verify whether a point lies on the circle by determining whether the distance between the given point and the center is equal to the radius.
3. To prove properties about special parallelograms on a coordinate plane, you can use the partitioning of a segment, distance, and slope formulas:

- The partitioning of a segment formula is $(x, y)=\left(\frac{b x_{1}+a x_{2}}{b+a}, \frac{b y_{1}+a y_{2}}{b+a}\right)$ or $(x, y)=\left(x_{1}+\frac{a}{a+b}\left(x_{2}+x_{1}\right), y_{1}+\frac{a}{a+b}\left(y_{2}+y_{1}\right)\right.$. This formula is used to find the coordinates of a point which partitions a directed line segment $A B$ at the ratio of $a: b$ from $A\left(x_{1}, y_{1}\right)$ to $B\left(x_{2}, y_{2}\right)$. This formula can also be used to derive the midpoint formula.
The midpoint formula is $\left(\frac{x_{1}+x_{2}}{2}, \frac{y_{1}+y_{2}}{2}\right)$. This formula is used to find the coordinates of the midpoint of $\overline{A B}$, given $A\left(x_{1}, y_{1}\right)$ and $B\left(x_{2}, y_{2}\right)$.
- The distance formula is $d=\sqrt{\left(x_{2}-x_{1}\right)^{2}+\left(y_{2}-y_{1}\right)^{2}}$. This formula is used to find the length of $\overline{A B}$, given $A\left(x_{1}, y_{1}\right)$ and $B\left(x_{2}, y_{2}\right)$.
- The slope formula is $m=\left(\frac{y_{2}-y_{1}}{x_{2}-x_{1}}\right)$. This formula is used to find the slope of a line or line segment, given any two points on the line or line segment $A\left(x_{1}, y_{1}\right)$ and $B\left(x_{2}, y_{2}\right)$. Slopes can be positive, negative, 0 , or undefined.


4. To prove a triangle is isosceles, you can use the distance formula to show that at least two sides are congruent.
5. You can use properties of quadrilaterals to help prove theorems:

- To prove a quadrilateral is a parallelogram, show that the opposite sides are parallel using slope.
- To prove a quadrilateral is a rectangle, show that the opposite sides are parallel and the consecutive sides are perpendicular using slope.
- To prove a quadrilateral is a rhombus, show that all four sides are congruent using the distance formula.
- To prove a quadrilateral is a square, show that all four sides are congruent and consecutive sides are perpendicular using slope and the distance formula.

6. You can also use diagonals of a quadrilateral to help prove theorems:

- To prove a quadrilateral is a parallelogram, show that its diagonals bisect each other using the midpoint formula.
- To prove a quadrilateral is a rectangle, show that its diagonals bisect each other and are congruent using the midpoint and distance formulas.
- To prove a quadrilateral is a rhombus, show that its diagonals bisect each other and are perpendicular using the midpoint and slope formulas.
- To prove a quadrilateral is a square, show that its diagonals bisect each other, are congruent, and are perpendicular using the midpoint, distance, and slope formulas.

7. A directed line segment is a line segment from one point to another point in the coordinate plane.


## Example:

Notice on $\overline{A B}$ we can subtract to find the difference of the $x$ - and $y$-values of $Q$ and $P:(9-5,6-4)=(4,2)$. They tell you that a "route" from $P$ to $Q$ is 4 units right and 2 units up. Note that these are used in the slope: $\frac{6-4}{9-5}=\frac{2}{4}=\frac{1}{2}$.


## Important Tips

2. When using the formulas for partitioning of a segment, distance, and slope, the order of the points does not matter. You can use either point to be ( $x_{1}, y_{1}$ ) and $\left(x_{2}, y_{2}\right)$, but be careful to always subtract in the same order.
3. Parallel lines have the same slope. Perpendicular lines have slopes that are the negative reciprocal of each other.
\& When using directed line segments, pay close attention to the beginning and end points of the line. For example, the directed line segments $\overline{P Q}$ and $\overline{Q P}$ have the same length but different directions.

## REVIEW EXAMPLES

1. Quadrilateral $A B C D$ has vertices $A(-1,3), B(3,5), C(4,3)$, and $D(0,1)$. Is $A B C D$ a rectangle? Explain how you know.

## Solution:

First determine whether or not the figure is a parallelogram. If the figure is a parallelogram, then the diagonals bisect each other. If the diagonals bisect each other, then the midpoints of the diagonals are the same point. Use the midpoint formula to determine the midpoints for each diagonal.

Midpoint $\overline{A C}:\left(\frac{x_{1}+x_{2}}{2}, \frac{y_{1}+y_{2}}{2}\right)=\left(\frac{-1+4}{2}, \frac{3+3}{2}\right)=\left(\frac{3}{2}, \frac{6}{2}\right)=(1.5,3)$
Midpoint $\overline{B D}:\left(\frac{x_{1}+x_{2}}{2}, \frac{y_{1}+y_{2}}{2}\right)=\left(\frac{3+0}{2}, \frac{5+1}{2}\right)=\left(\frac{3}{2}, \frac{6}{2}\right)=(1.5,3)$
The diagonals have the same midpoint; therefore, the diagonals bisect each other and the figure is a parallelogram.

A parallelogram with congruent diagonals is a rectangle. Determine whether or not the diagonals are congruent.

Use the distance formula to find the length of the diagonals:
$A C=\sqrt{(4-(-1))^{2}+(3-3)^{2}}=\sqrt{(5)^{2}+(0)^{2}}=\sqrt{25+0}=\sqrt{25}=5$
$B D=\sqrt{(0-3)^{2}+(1-5)^{2}}=\sqrt{(-3)^{2}+(-4)^{2}}=\sqrt{9+16}=\sqrt{25}=5$
The diagonals are congruent because they have the same length.
The figure is a parallelogram with congruent diagonals, so the figure is a rectangle.
2. Circle $C$ has a center of $(-2,3)$ and a radius of 4 . Does point $(-4,6)$ lie on circle $C$ ?

## Solution:

The distance from any point on the circle to the center of the circle is equal to the radius. Use the distance formula to find the distance from $(-4,6)$ to the center $(-2,3)$. Then see if it is equal to the radius, 4 .

$$
\begin{array}{ll}
\sqrt{(-4-(-2))^{2}+(6-3)^{2}} & \begin{array}{l}
\text { Substitute the coordinates of the points in } \\
\text { the distance formula. }
\end{array} \\
\sqrt{(-2)^{2}+(3)^{2}} & \text { Evaluate within parentheses. } \\
\sqrt{4+9} & \text { Evaluate the exponents. } \\
\sqrt{13} & \text { Add. }
\end{array}
$$

The distance from $(-4,6)$ to $(-2,3)$ is not equal to the radius, so $(-4,6)$ does not lie on the circle. (In fact, since $\sqrt{13}<4$, the distance is less than the radius, so the point lies inside of the circle.)
3. Follow the steps below to prove that if two nonvertical lines are parallel, then they have equal slopes.
a. Let the straight lines $n$ and $m$ be parallel. Sketch these on a coordinate grid.

b. Plot any points $B$ and $D$ on line $m$ and the point $E$ so that segment $B E$ is the rise and segment $E D$ is the run of the slope of line $m$. (A straight line can have only one slope.)


That is, slope of line $m$ is $\frac{B E}{E D}$.
c. Draw the straight line $B E$ so that it intersects line $n$ at point $A$ and extends to include point $F$ such that segment $F C$ is perpendicular to $B E$.

d. What is the slope of line $n$ ?

## Solution:

The slope is $\frac{A F}{F C}$.
e. Line $B F$ is the $\qquad$ of lines $m$ and $n$, so $\angle E B D$ and $\angle F A C$ are $\qquad$ angles, so $\angle E B D$ $\qquad$ $\angle F A C$.

## Solution:

transversal, corresponding, congruent
f. Why is it true that $\angle D E B \cong \angle A F C$ ?

## Solution:

The angles are right angles.
g. Now, $\triangle D E B$ and $\triangle C F A$ are similar, so the ratio of their sides is proportional. Write the proportion that relates the vertical leg to the horizontal leg of the triangles.

## Solution:

$\frac{B E}{E D} \cong \frac{A F}{F C}$
h. Note that this proportion shows the slope of line $m$ is the same as the slope of line $n$. Therefore, parallel lines have the same slope.
4. Prove that if two nonvertical lines have equal slopes, then they are parallel.

## Solution:



Use a proof by contradiction. Assume that the lines have equal slopes but are not parallel-that is, assume the lines intersect. If you can show this is not true, it is equivalent to proving the original statement.

Write the equations for both lines. The slopes are the same, so use $m$ for the slope of each line. The two lines are different, so $b_{1} \neq b_{2}$.
Equation for line $n: y=m x+b_{1}$
Equation for line $m: y=m x+b_{2}$
Solve a system of equations to find the point of intersection. Both equations are solved for $y$, so use substitution.

$$
\begin{aligned}
m x+b_{1} & =m x+b_{2} \\
b_{1} & =b_{2}
\end{aligned}
$$

Because it was assumed that $b_{1} \neq b_{2}$, this is a contradiction. So the original statement is true-if two nonvertical lines have equal slopes, then they are parallel.
5. The line $p$ is represented by the equation $y=4 x+1$. What is the equation of the line that is perpendicular to line $p$ and passes through the point $(8,5)$ ?

## Solution:

On a coordinate grid, graph the line $y=4 x+1$. Locate points $Y$ and $Z$ on the line $y=4 x+1$ such that the slope of $\frac{X Z}{Y Z}=4$. Rotate triangle $X Y Z$ around point $X$ $90^{\circ}$. Name the new triangle $X^{\prime} Y^{\prime} Z^{\prime}$. $X^{\prime}$ and $Y^{\prime}$ lie on line $X^{\prime} Y^{\prime}$ so that line $X^{\prime} Y^{\prime}$ passes through the point $(8,5)$ and has a slope of $-\frac{1}{4}$.


The slope-intercept form of the equation of a line is $y=m x+b$. Substitute $-\frac{1}{4}$ for $m$. The line perpendicular to line $p$ passes through $(8,5)$, so substitute 8 for $x$ and 5 for $y$. Solve for $b$.

$$
\begin{aligned}
& 5=-\frac{1}{4}(8)+b \\
& 5=-2+b \\
& 7=b
\end{aligned}
$$

The equation of the line perpendicular to line $p$ and that passes through $(8,5)$ is $y=-\frac{1}{4} x+7$.
6. For what value of $n$ are the lines $7 x+3 y=8$ and $n x+3 y=8$ perpendicular?

## Solution:

The two lines will be perpendicular when the slopes are opposite reciprocals.
First, find the slope of the line $7 x+3 y=8$.

$$
\begin{aligned}
7 x+3 y & =8 \\
3 y & =-7 x+8 \\
y & =-\frac{7}{3} x+\frac{8}{3}
\end{aligned}
$$

The slope is $-\frac{7}{3}$.
Next, find the slope of the line $n x+3 y=8$, in terms of $n$.

$$
\begin{aligned}
n x+3 y & =8 \\
3 y & =-n x+8 \\
y & =-\frac{n}{3} x+\frac{8}{3}
\end{aligned}
$$

The slope is $-\frac{n}{3}$.
The opposite reciprocal of $-\frac{7}{3}$ is $\frac{3}{7}$. Find the value of $n$ that makes the slope of the second line $\frac{3}{7}$.

$$
\begin{aligned}
-\frac{n}{3} & =\frac{3}{7} \\
-n & =\frac{9}{7} \\
n & =-\frac{9}{7}
\end{aligned}
$$

When $n=-\frac{9}{7}$, the two lines are perpendicular.
7. Quadrilateral $A B C D$ has vertices $A(4,0), B(3,3), C(-3,1)$, and $D(-2,-2)$. Prove that $A B C D$ is a rectangle.

## Solution:

The slopes of the sides are:

$$
\begin{array}{ll}
\overline{A B}: \frac{3-0}{3-4}=\frac{3}{-1}=-3 & \overline{B C}: \frac{1-3}{-3-3}=\frac{-2}{-6}=\frac{1}{3} \\
\overline{C D}: \frac{-2-1}{-2+3}=\frac{-3}{1}=-3 & \overline{D A}: \frac{0+2}{4+2}=\frac{2}{6}=\frac{1}{3}
\end{array}
$$


$\overline{A B} \| \overline{C D}$ because they have equal slopes.
$\overline{B C} \| \overline{D A}$ because they have equal slopes.
So $A B C D$ is a parallelogram because both pairs of opposite sides are parallel.
$\overline{A B} \perp \overline{B C}$ because the product of their slopes is -1 : $-3 \cdot \frac{1}{3}=-1$.
Therefore, $A B C D$ is a rectangle because it is a parallelogram with a right angle.
8. Given the points $A(-1,2)$ and $B(7,8)$, find the coordinates of the point $P$ on directed line segment $\overline{A B}$ that partitions $\overline{A B}$ in the ratio 1:3.


## Solution:

Point $P$ partitions $\overline{A B}$ in the ratio 1:3 if $P$ is on $\overline{A B}$. This means that you need to divide $\overline{A B}$ into 4 equal parts, since $\overline{A P}=$ one-fourth of $\overline{A B}$.


Let $P(x, y)$ be on $\overline{A B}$. Solve two equations to find $x$ and $y$, where $\left(x_{1}, y_{1}\right)$ is the starting point, $\left(x_{2}, y_{2}\right)$ is the ending point, and $\frac{a}{(a+b)}=\frac{1}{4}$.

$$
\begin{aligned}
& (x, y)=\left(x_{1}+\frac{a}{a+b}\left(x_{2}-x_{1}\right), y_{1}+\frac{a}{a+b}\left(y_{2}-y_{1}\right)\right) \\
& (x, y)=\left(-1+\frac{1}{4}(7-(-1)), 2+\frac{1}{4}(8-2)\right) \\
& x=-1+\frac{1}{4}(7-(-1)) \quad y=2+\frac{1}{4}(8-2) \\
& x=-1+\frac{1}{4}(8) \quad y=2+\frac{1}{4}(6) \\
& \begin{array}{ll}
x=-1+2 \\
x=1
\end{array} \quad y=2+\frac{3}{2} \\
& y=\frac{7}{2}
\end{aligned}
$$

The coordinates of $P$ are $\left(1, \frac{7}{2}\right)$.
Here is another method for partitioning segment $A B$ in the ratio 1:3 from $A\left(x_{1}, y_{1}\right)$ to $B\left(x_{2}, y_{2}\right)$.

$$
\begin{aligned}
(x, y) & =\frac{b x_{1}+a x_{2}}{b+a}, \frac{b y_{1}+a y_{2}}{b+a} \\
& =\frac{3(-1)+1(7)}{3+1}, \frac{3(2)+1(8)}{3+1} \\
& =\frac{-3+7}{4}, \frac{6+8}{4} \\
& =\frac{4}{4}, \frac{14}{4} \\
& =\left(1, \frac{7}{2}\right)
\end{aligned}
$$

## Important Tip

2. Be careful when using directed line segments. If point $P$ partitions $\overline{A B}$ in the ratio

1:3, then point $P$ partitions $\overline{B A}$ in the ratio 3:1.
9. Find the area of rectangle $A B C D$ with vertices $A(-3,0), B(3,2), C(4,-1)$, and $D(-2,-3)$.

## Solution:



One strategy is to use the distance formula, $d=\sqrt{\left(x_{2}-x_{1}\right)^{2}+\left(y_{2}-y_{1}\right)^{2}}$, to find the length and width of the rectangle.

$$
\begin{aligned}
& A B=\sqrt{(3-(-3))^{2}+(2-0)^{2}}=\sqrt{36+4}=\sqrt{40} \\
& B C=\sqrt{(4-3)^{2}+(-1-2)^{2}}=\sqrt{1+9}=\sqrt{10}
\end{aligned}
$$

The length of the rectangle is usually considered to be the longer side. Therefore, the length of the rectangle is $\sqrt{40}$ and the width is $\sqrt{10}$.

NOTE: Other strategies are possible to find the length of $A B$ and $B C$ such as using the Pythagorean theorem.

Use the area formula.

$$
\begin{aligned}
& A=I W \\
& A=(\sqrt{40})(\sqrt{10}) \\
& A=\sqrt{400} \\
& A=20
\end{aligned}
$$

The area of the rectangle is 20 square units.

## UNIT 6: APPLICATIONS OF PROBABILITY

This unit investigates the concept of probability. Students look at sample spaces and identify unions, intersections, and complements. They identify ways to tell whether events are independent. The concept of conditional probability is related to independence, and students use the concepts to solve real-world problems, including those that are presented in two-way frequency tables. Students find probabilities of compound events using the rules of probability.

## Understand Independence and Conditional Probability and Use Them to Interpret Data

MGSE9-12.S.CP. 1 Describe categories of events as subsets of a sample space using unions, intersections, or complements of other events (or, and, not).

MGSE9-12.S.CP. 2 Understand that if two events $A$ and $B$ are independent, the probability of $A$ and $B$ occurring together is the product of their probabilities, and that if the probability of two events $A$ and $B$ occurring together is the product of their probabilities, the two events are independent.

MGSE9-12.S.CP. 3 Understand the conditional probability of A given B as $P$ ( $A$ and $B$ ) $/ P(B)$. Interpret independence of $A$ and $B$ in terms of conditional probability; that is, the conditional probability of $A$ given $B$ is the same as the probability of $A$, and the conditional probability of $B$ given $A$ is the same as the probability of $B$.

MGSE9-12.S.CP. 4 Construct and interpret two-way frequency tables of data when two categories are associated with each object being classified. Use the two-way table as a sample space to decide if events are independent and to approximate conditional probabilities. For example, use collected data from a random sample of students in your school on their favorite subject among math, science, and English. Estimate the probability that a randomly selected student from your school will favor science given that the student is in tenth grade. Do the same for other subjects and compare the results.

MGSE9-12.S.CP. 5 Recognize and explain the concepts of conditional probability and independence in everyday language and everyday situations. For example, compare the chance of having lung cancer if you are a smoker with the chance of being a smoker if you have lung cancer.

## KEY IDEAS

1. In probability, a sample space is the set of all possible outcomes. Any subset from the sample space is an event.
2. If the outcome of one event does not change the possible outcomes of the other event, the events are independent. If the outcome of one event does change the possible outcomes of the other event, the events are dependent.
3. The intersection of two or more events is all of the outcomes shared by both events. The intersection is denoted with the word "and" or with the $\cap$ symbol. For example, the intersection of $A$ and $B$ is shown as $A \cap B$.
4. The union of two or more events is all of the outcomes for either event. The union is denoted with the word "or" or with the $\cup$ symbol. For example, the union of $A$ and $B$ is shown as $A \cup B$. The probability of the union of two events that have no outcomes in common is the sum of each individual probability.
5. The complement of an event is the set of outcomes in the same sample space that are not included in the outcomes of the event. The complement is denoted with the word "not" or with the ' symbol. For example, the complement of $A$ is shown as $A^{\prime}$. The set of outcomes and its complement make up the entire sample space.
6. Conditional probabilities are found when one event has already occurred and a second event is being analyzed. Conditional probability is denoted $P(A \mid B)$ and is read as "the probability of $A$ given $B$."

$$
P(A \mid B)=\frac{P(A \text { and } B)}{P(B)}
$$

7. Two events- $A$ and $B$-are independent if the probability of the intersection is the same as the product of each individual probability. That is, $P(A$ and $B)=P(A) \cdot P(B)$.
8. If two events are independent, then $P(A \mid B)=P(A)$ and $P(B \mid A)=P(B)$.
9. Two-way frequency tables summarize data in two categories. These tables can be used to show whether the two events are independent and to approximate conditional probabilities.

## Example:

A random survey was taken to gather information about grade level and car ownership status of students at a school. This table shows the results of the survey.

Car Ownership by Grade

|  | Owns a Car | Does Not Own <br> a Car | Total |
| :--- | :---: | :---: | :---: |
| Junior | 6 | 10 | 16 |
| Senior | 12 | 8 | 20 |
| Total | 18 | 18 | 36 |

Estimate the probability that a randomly selected student will be a junior, given that the student owns a car.

## Solution:

Let $P(J)$ be the probability that the student is a junior. Let $P(C)$ be the probability that the student owns a car.

$$
P(J \mid C)=\frac{P(J \text { and } C)}{P(C)}=\frac{\frac{6}{36}}{\frac{18}{36}}=\frac{6}{18}=\frac{1}{3}
$$

The probability that a randomly selected student will be a junior given that the student owns a car is $\frac{1}{3}$.

## REVIEW EXAMPLES

1. This table shows the names of students in Mr. Leary's class who do or do not own bicycles and skateboards.

|  | Bicycle and Skateboard Ownership |  |  |
| :---: | :---: | :---: | :---: |
| Owns a <br> Bicycle | Owns a <br> Skateboard | Owns a <br> Bicycle AND <br> Skateboard | Does NOT Own <br> a Bicycle OR <br> Skateboard |
| Ryan | Brett | Joe | Amy |
| Sarah | Juan | Mike | Gabe |
| Mariko | Tobi | Linda | Abi |
| Nina |  | Rose |  |
| Dion |  |  |  |

Let set $A$ be the names of students who own bicycles, and let set $B$ be the names of students who own skateboards.
a. Find $A$ and $B$. What does the set represent?
b. Find $A$ or $B$. What does the set represent?
c. Find $(A \text { or } B)^{\prime}$. What does the set represent?

## Solution:

a. The intersection is the set of elements that are common to both set $A$ and set $B$, so $A$ and $B$ is \{Joe, Mike, Linda, Rose\}. This set represents the students who own both a bicycle and a skateboard.
b. The union is the set of elements that are in set $A$ or set $B$ or in both set $A$ and set $B$. You only need to list the names in the intersection one time, so $A$ or $B$ is \{Ryan, Sarah, Mariko, Nina, Dion, Joe, Mike, Linda, Rose, Brett, Juan, Tobi\}. This set represents the students who own a bicycle, a skateboard, or both.
c. The complement of $A$ or $B$ is the set of names that are not in $A$ or $B$. So, the complement of $A$ or $B$ is $\{A m y$, Gabe, Abi\}. This set represents the students who own neither a bicycle nor a skateboard.
2. In a certain town, the probability that a person plays sports is $65 \%$. The probability that a person is between the ages of 12 and 18 is $40 \%$. The probability that a person plays sports and is between the ages of 12 and 18 is $25 \%$. Are the events independent? How do you know?

## Solution:

Let $P(S)$ be the probability that a person plays sports.
Let $P(A)$ be the probability that a person is between the ages of 12 and 18 .
If the two events are independent, then $P(S$ and $A)=P(S) \cdot P(A)$.
Because $P(S$ and $A)$ is given as $25 \%$, find $P(S) \cdot P(A)$ and then compare.

$$
\begin{aligned}
P(S) \cdot P(A) & =0.65 \cdot 0.4 \\
& =0.26
\end{aligned}
$$

Because $0.26 \neq 0.25$, the events are not independent.
3. A random survey was conducted to gather information about age and employment status. This table shows the data that were collected.

## Employment Survey Results

|  | Age (in Years) |  |  |
| :--- | :---: | :---: | :---: |
| Employment Status | Less than $\mathbf{1 8}$ | $\mathbf{1 8}$ or greater | Total |
| Has Job | 20 | 587 | 607 |
| Does Not Have Job | 245 | 92 | 337 |
| Total | 265 | 679 | 944 |

a. What is the probability that a randomly selected person surveyed has a job, given that the person is less than 18 years old?
b. What is the probability that a randomly selected person surveyed has a job, given that the person is greater than or equal to 18 years old?
c. Are having a job $(A)$ and being 18 or greater $(B)$ independent events? Explain.

- $P(A)=$ has a job
- $P\left(A^{\prime}\right)=$ does not have a job
- $P(B)=18$ years old or greater
- $P\left(B^{\prime}\right)=$ less than 18 years old


## Solution:

a. Find the total number of people surveyed less than 18 years old: $20+245=265$. Divide the number of people who have a job and are less than 18 years old, 20, by the number of people less than 18 years old, 265 : $\frac{20}{265} \approx 0.08$. The probability that a person surveyed has a job, given that the person is less than 18 years old, is about 0.08 .

$$
P\left(A \mid B^{\prime}\right)=\frac{P\left(A \text { and } B^{\prime}\right)}{P\left(B^{\prime}\right)}=\frac{\frac{20}{944}}{\frac{265}{944}}=\frac{20}{265}=0.08
$$

b. Find the total number of people surveyed greater than or equal to 18 years old: $587+92=679$. Divide the number of people who have a job and are greater than or equal to 18 years old, 587, by the number of people greater than or equal to 18 years old, $679: \frac{587}{679} \approx 0.86$. The probability that a person surveyed has a job, given that the person is greater than or equal to 18 years old, is about 0.86.

$$
P(A \mid B)=\frac{P(A \text { and } B)}{P(B)}=\frac{\frac{587}{944}}{\frac{679}{944}}=\frac{587}{679}=0.86
$$

c. The events are independent if $P(A \mid B)=P(A)$ and $P(B \mid A)=P(B)$.

From part (b), $P(A \mid B) \approx 0.86$.
$P(A)=\frac{607}{944} \approx 0.64$
$P(A \mid B) \neq P(A)$, so the events are not independent.

MGSE9-12.S.CP. 6 Find the conditional probability of $A$ given $B$ as the fraction of $B$ 's outcomes that also belong to $A$, and interpret the answer in context.

MGSE9-12.S.CP. 7 Apply the Addition Rule, $P(A$ or $B)=P(A)+P(B)-P(A$ and $B)$, and interpret the answers in context.

## KEY IDEAS

1. Two events are mutually exclusive if the events cannot occur at the same time.
2. When two events $A$ and $B$ are mutually exclusive, the probability that event $A$ or event $B$ will occur is the sum of the probabilities of each event: $P(A$ or $B)=P(A)+P(B)$.
3. When two events $A$ and $B$ are not mutually exclusive, the probability that event $A$ or $B$ will occur is the sum of the probability of each event minus the intersection of the two events. That is, $P(A$ or $B)=P(A)+P(B)-P(A$ and $B)$.
4. You can find the conditional probability, $P(A \mid B)$, by finding the fraction of $B$ 's outcomes that also belong to $A$.

## Example:

Event $A$ is choosing a heart card from a standard deck of cards.
Event $B$ is choosing a face card from a standard deck of cards.
$P(A \mid B)$ is the probability that a card is a heart, given that the card is a face card. You can look at $B$ 's outcomes and determine what fraction belongs to $A$; there are 12 face cards, 3 of which are also hearts:
$P(A \mid B)=\frac{3}{12}=\frac{1}{4}$.

|  | Heart | Not a heart | Total |
| :--- | :---: | :---: | :---: |
| Face card | 3 | 9 | 12 |
| Not a face card | 10 | 30 | 40 |
| Total | 13 | 39 | 52 |

## REVIEW EXAMPLES

1. In Mr. Mabry's class, there are 12 boys and 16 girls. On Monday, 4 boys and 5 girls were wearing white shirts.
a. If a student is chosen at random from Mr. Mabry's class, what is the probability of choosing a boy or a student wearing a white shirt?
b. If a student is chosen at random from Mr. Mabry's class, what is the probability of choosing a girl or a student not wearing a white shirt?

## Solution:

a. Apply the Addition Rule, $P(A$ or $B)=P(A)+P(B)-P(A$ and $B)$, where $A$ is the set of boys and $B$ is the set of students wearing a white shirt.
$(A$ and $B)$ is the set of boys wearing a white shirt. There are $12+16=28$ students in Mr. Mabry's class.
So, $P(A)=\frac{12}{28}, P(B)=\frac{4+5}{28}=\frac{9}{28}$, and $P(A$ and $B)=\frac{4}{28}$.
$P($ a boy or a student wearing a white shirt $)=\frac{12}{28}+\frac{9}{28}-\frac{4}{28}=\frac{17}{28}$
b. Apply the Addition Rule, $P(A$ or $B)=P(A)+P(B)-P(A$ and $B)$, where $A$ is the set of girls and $B$ is the set of students not wearing a white shirt.
$(A$ and $B)$ is the set of girls not wearing a white shirt. There are $12+16=28$ students in Mr. Mabry's class.

So, $P(A)=\frac{16}{28}, P(B)=\frac{8+11}{28}=\frac{19}{28}$, and $P(A$ and $B)=\frac{11}{28}$.
$P($ a girl or a student not wearing a white shirt $)=\frac{16}{28}+\frac{19}{28}-\frac{11}{28}=\frac{24}{28}=\frac{6}{7}$
2. Terry has a number cube with sides labeled 1 through 6 . He rolls the number cube twice.
a. What is the probability that the sum of the two rolls is a prime number, given that at least one of the rolls is a 3 ?
b. What is the probability that the sum of the two rolls is a prime number or at least one of the rolls is a 3 ?

## Solution:

a. This is an example of a mutually exclusive event. Make a list of the combinations where at least one of the rolls is a 3 . There are 11 such pairs.

| 1,3 | 2,3 | 3,3 | 4,3 | 5,3 | 6,3 |
| :--- | :--- | :--- | :--- | :--- | :--- |
| 3,1 | 3,2 | 3,4 | 3,5 | 3,6 |  |

Then identify the pairs that have a prime sum.

$$
\begin{array}{|l|l|l|l|}
\hline 2,3 & 3,2 & 3,4 & 4,3 \\
\hline
\end{array}
$$

Of the 11 pairs of outcomes, there are 4 pairs whose sum is prime. Therefore, the probability that the sum is prime of those that show a 3 on at least one roll is $\frac{4}{11}$.
b. This is an example of events that are NOT mutually exclusive. There are 36 possible outcomes when rolling a number cube twice.
List the combinations where at least one of the rolls is a 3 .

| 1,3 | 2,3 | 3,3 | 4,3 | 5,3 | 6,3 |
| :--- | :--- | :--- | :--- | :--- | :--- |
| 3,1 | 3,2 | 3,4 | 3,5 | 3,6 |  |

$P($ at least one roll is a 3$)=\frac{11}{36}$
List the combinations that have a prime sum.

| 1,1 | 1,2 | 1,4 | 1,6 |
| :--- | :--- | :--- | :--- |
| 2,1 | 2,3 | 2,5 |  |
| 3,2 | 3,4 |  |  |
| 4,1 | 4,3 |  |  |
| 5,2 | 5,6 |  |  |
| 6,1 | 6,5 |  |  |

$P($ a prime sum $)=\frac{15}{36}$

Identify the combinations that are in both lists.

$$
\begin{array}{|l|l|l|l|}
\hline 2,3 & 3,2 & 3,4 & 4,3 \\
\hline
\end{array}
$$

The combinations in both lists represent the intersection. The probability of the intersection is the number of outcomes in the intersection divided by the total possible outcomes.
$P($ at least one roll is a 3 and a prime sum $)=\frac{4}{36}$
If two events share outcomes, then outcomes in the intersection are counted twice when the probabilities of the events are added. So you must subtract the probability of the intersection from the sum of the probabilities.
$P($ at least one roll is a 3 or a prime sum $)=\frac{11}{36}+\frac{15}{36}-\frac{4}{36}=\frac{22}{36}=\frac{11}{18}$
